All exhibitors are responsible for their own displays. Exhibitors must supply their own tables, chairs, tents, etc. If you have your own tent, please advise us accordingly. **ALL COMMERCIAL EXHIBITS ARE OUTSIDE. THERE ARE NO INSIDE EXHIBITS.**

There will be a \$40 daily fee or \$100 for the whole fair. If you require an electrical hook-up, there will be an additional fee of \$25. Please check in at the livestock office (located at the northwest corner of the covered show ring) prior to setting up.
