A surcharge of \$30 will be assessed for all dishonored checks pursuant to Iowa Code 554.3512. **All exhibits will need to be approved by the fair board.**

All exhibitors are responsible for their own displays. Exhibitors must supply their own tables, chairs, tents, etc. If you have your own tent, please advise us accordingly. **ALL COMMERCIAL EXHIBITS ARE OUTSIDE. THERE ARE NO INSIDE EXHIBITS.**

There will be a \$40 daily fee or \$100 for the whole fair. If you require an electrical hook-up, there will be an additional fee of \$25. Please check in at the livestock office (located at the northwest corner of the covered show ring) prior to setting up.

7. ALL EXHIBITORS WILL HAVE TO PROVIDE THEIR OWN SUPPLEMENTAL INSURANCE. A COPY MUST BE ON FILE AT THE FAIR OFFICE PRIOR TO SET-UP.
8. THE FAIR BOARD RESERVES THE FINAL & ABSOLUTE RIGHT TO HAVE EXHIBITORS REMOVE ANY AND ALL ITEMS (for sale or display) THEY DEEM INAPPROPRIATE FOR THE FAIR SETTING.
