Official Fair Veterinarians – Grinnell Vet Clinic serves as the Poweshiek County Fair Veterinarian(s). If an animal is in need of veterinary care while at the fair a veterinarian can be reached at 641 236-4461. Veterinary care will be provided at the owner's expense. Payment at the time of service is also required in the form of cash or check. Grinnell Veterinary Clinic will charge \$25.00 for a trip charge during normal business hours and \$50.00 after normal business hours. Services and medications to treat animals will be billed according to Grinnell Veterinary Clinic's normal fee structure and prices. Exhibitors are not required to use the fair veterinarian for treatment. Personal veterinarian may be called.

The Poweshiek County Fair Queen Pageant will be held on stage in the show ring Thursday, July 15th. Contestants will be judged on interview, self introduction, speech and impromptu question. Personal interview time to be announced. This is not a beauty pageant! A talent is not required. The newly crowned queen and court will preside over the Poweshiek County Fair beginning at 8:00 am on Friday July 16th and continue through the conclusion of the fair. The queen will also return the following year to assist with conference judging and the first day (Thursday) of livestock judging. The queen will also represent Poweshiek County at the Iowa State Fair Queen Pageant held in August. Contestants must be at least 16 years of age and not more than 21 years of age the first day of the current Iowa State Fair. It is very important that you are available for all the events and judging at the state fair. Approval for schedule change requests will be very limited. Complete rules and entry forms are available at the fair office or online at poweshiekcountyfair.org. Entries are due June 15th at the fair office

Little Miss entries are due at the fair office June 15th. Girls ages 6-8 are eligible. Forms and information are available at poweshiekcountyfair.org

Poweshiek County Fair General Information

Dogs are only allowed in the campgrounds during fair week unless they are being shown or they are a service animal. Dogs are not to be in or around buildings, show ring, arena, parking lots etc. This policy is for the safety of the public, exhibitors and livestock.

County Fair Club Display: Alumni of Poweshiek County 4-H are encouraged to return to the Poweshiek County Fair. Clubs can make a poster showing significant honors, traditions, community service projects or accomplishments of their club through the years.

Camping: All returning campers must have their completed reservation form and fee of \$100 into the fair office by May 15. The camping fee will reserve the spot you were assigned last year for those who camped at the Poweshiek Co. Fair. ATTENTION:

Late registrations for returning campers will no longer be allowed. If you do not submit your camping registration form and \$100 fee by May 15th your camping spot will be reassigned. Those returning campers who miss the renewal deadline may ask to be placed on the new camper waiting list at the fair office. The order of the list will be determined by a first entry received basis. Those on the waiting list will be notified of available spots ASAP after May 15th. New campers will have 7 days following notification to submit their registration form and pay the \$100 camping fee. If not submitted within the 7 days camper will lose their spot. The fair office must have a completed reservation form for every camping spot occupied.

- 1. Electrical plug ends must be 10-3 cord or heavier. Anything less will be unplugged.
- 2. Each camping unit is allowed 1-40 Amp & 1-110 electrical hookup.
- 3. The campground opens for fair camping on Saturday, July 10th, 6 a.m. NO EARLY CAMPERS ALLOWED (with the exception to west side, back row campers). NEW! WEST SIDE, BACK ROW CAMPERS MAY ARRIVE ON FRIDAY STARTING AT 5 P.M. THEY MUST BE IN PLACE BY NOON ON SATURDAY. IF YOU ARE UNABLE TO PARK YOUR CAMPER DURING THIS TIME CONTACT THE CAMPING SUPERINTENDENT. West side front row campers may start arriving at noon on Saturday July 10th. East side campers may start arriving at 6 am on July 10th. All campers must be in place by July 14th at 6:00 pm to secure camping spot. Please note the electricity will not be turned on until Tuesday, July 13th at noon. The fair will not be responsible for spoiled food or any other problems arising from no power to your camper.
- 4. 2021 Poweshiek Co. Fair Queen will be provided a camping spot.
- 5. Tents will be charged \$25.00. <u>All individual tents NOT set-up in a designated camping spot must be placed in the designated tent area.</u>
- 6. All electrical camping spots will be charged \$100.00, whether or not they are hooked up to electricity.
- 7. One camping unit per plug in.
- 8. PCFA will not be responsible for electrical malfunctions that result in damage to campers or equipment.
- 9. PCFA will not be liable for theft or damage of any article caused by fire or any act of God.
- 10. No minors under 18 years of age will be allowed to camp without adult supervision.

- 11. Campers in non-electric spots will be charged \$25.00.
- 12. If you bring your dog with you while camping at the fair they are to stay in the campgrounds. Dogs are not to be in or around buildings, show ring, arena, parking lots etc. during fair week. Only dogs being shown or service animals will be allowed out of the campground. This policy is for the safety of the public, exhibitors and livestock.
- 13. Campers will be limited to 2 vehicles per camping spot. Please park your extra vehicles in the parking lot east of the Exhibit Building. This will alleviate the overcrowding in the camping area making it possible for everyone to come and go as needed.

Returning campers send \$100.00 with <u>completed reservation form to:</u> PCFA Camping, P.O. Box 372, Grinnell, IA 50112 by May 15.

New campers once notified of an opening will have 7 days to submit their registration form and fee.

Camping reservation form and fee may also be dropped off at the fair office using the drop box (located by the office door) after regular office hours.

Poweshiek County Fair Association Membership: Any person over the age of 18 (as of the last Friday of August of the current year may become a member of the Poweshiek County Fair Association by paying a membership fee of \$5.00 annually. Dues must be paid to the fair office no later than 4:30 p.m. the last Friday of August to be eligible to vote and serve on the board of directors. Dues sent by mail must be postmarked no later than the last Friday in August. Fairboard nomination forms must be received by a 3rd party designated by the fairboard no later than 4:30 p.m. the last Friday of August of current year. The 2021 annual meeting is set for October 4th. Fair association dues may be paid at the livestock office located in the covered show ring during the county fair.

Premiums: The fairboard will pay premiums to individual exhibitors by September 30th. In the event that the fair association has insufficient funds to pay the full premiums (with a cap of \$30 per member), the board of directors shall pro-rate all premiums. **Checks will be void after 90 days of issue date.**

Talent Show: The Poweshiek County Fair Talent Show will be held Thursday, July 15th at 8:00 P.M. in the show ring. For further information contact Carri Burnett at cburnett@montezuma.k12.ia.us after June 1st. **Talent show entry forms are available at poweshiekcountyfair.org.**

DRESS CODE

To create uniformity and eliminate confusion the Poweshiek County Fairboard has established the following dress code for exhibiting at the Poweshiek County 4H/FFA Fair with the exception of horse exhibitors who have a set dress code.

SHIRTS – All exhibitors in conference judging, show ring/livestock judging and project sale are expected to wear a 4H/FFA logoed shirt of any color with the 4H/FFA emblem or wording attached to it. Official Iowa State Fair t-shirts are also acceptable. Any shirt with inappropriate wording or graphics will not be allowed. See Communications Event Day attire for exceptions. 4H t-shirts and patches may be purchased through club leaders. See your FFA chapter advisor for FFA shirts. Clover Kids (k-3rd grade) will wear their club t-shirt

BOTTOMS – **NO SHORTS ALLOWED.** Conference judging exhibitors are required to wear blue jeans or blue skirt (jean skirt acceptable).

Show ring/livestock judging and project sale exhibitors are required to wear blue jeans.

No holes or tears allowed in jeans or jean skirt.

FOOTWEAR – All exhibitors will wear tie shoes or boots.

No ball caps or hats are allowed while exhibiting or participating in the project sale.

Exhibitors in violation of the dress code will forfeit all premium money in each division the dress code is not followed. Exhibitors violating the dress code for the project sale will forfeit premiums in the division that they are selling projects/livestock. In certain cases exhibitors may forfeit all premium money.

IOWA STATE FAIR SELECTION OF CONFERENCE JUDGED EXHIBITS: The exhibit building will be closed to the public when conference judging is done. This will allow the judges to make Iowa State Fair exhibit selections.

Pre Fair Booth Set Up: Wednesday July 7th – 4 to 7 pm The Exhibit Building will be open during this time for booth set up and decoration. **NOTICE: Only painters tape may be used to secure items to the floor of the Exhibit Building.** Duck tape, masking tape etc. is not allowed. **Nothing is to be attached to the walls or on the acoustic panels.** Attention: It is the responsibility of the club members and leaders to disassemble and return entire project display (tables, back drops etc.) to the proper storage place at the conclusion of the fair. All trash and debris must be placed in trash cans.

PREMIER EXHIBITOR

The Premier Exhibitor award was developed to encourage and award 4-H and FFA exhibitors with a diverse fair experience by entering multiple divisions and departments. In an effort to level the playing field for all indoor departments, outdoor divisions, 4-H and FFA exhibitors, the following rules are applied:

- 1. No entry form needed.
- 2. FFA and 4-H exhibitors are eligible to qualify.
- 3. Only premium-eligible classes qualify for points.
- 4. Event Day entries are excluded.
- 5. Points are awarded as follows:

Purple – 4 Points

Blue – 3 Points

Red - 2 Points

White – 1 Point

Disqualified – 0 Points

- 6. No points for Grand, Reserve Grand, and Showmanship awards.
- 7. Cash payout will be for the top three exhibitors.
- 8. The total number of points awarded for ribbons by Division/ Department is capped at 15.
- 9. In the event of a tie, the following criteria will be used to determine the winner:
 - a. Total number of premium-eligible entries using the same eligibility as rules 1-6 with no cap by division/department.
 - b. In the event that there is still a tie after 8.a., total accumulation of points for all premium-eligible entries using the same eligibility as rules 1-6 with no cap by division/department.
 - c. In the event that there is still a tie after 8.b., a name will be drawn at random to determine a winner.

Since Jane has not exceeded the maximum of 15 points in the Sheep division, she was awarded the 3 points for the blue ribbon. Jane has 19 points.

Exhibit Building Host and Hostess Guidelines & Schedule

- In the Exhibit Building, host and hostesses from your club are needed to greet guests, guard displays and answer questions throughout the week of the fair.
- 2. Clubs are encouraged to provide a make-it-take-it craft for their scheduled time.
- 3. Each shift will be 2 hours in length. Each club should have 2 members and 1 adult present during the club's entire assigned time.
- 4. If you are representing your club, please report at the scheduled time.
- 5. Please remember you are representing your 4-H/Clover Kids club. Please follow the established dress code.
- 6. NO food is allowed in the exhibit area! Please remember this and do not bring food or drinks with you during your scheduled time.

General Rules for All Exhibits

If all rules are not followed by exhibitor and/or parent(s) at the sole discretion of the fairboard, exhibitor could be banned from showing at one or more Poweshiek County 4-H/FFA Fairs. Second offenses by exhibitor and/or parent(s) will result in lifetime suspension of the exhibitor from the Poweshiek County 4-H/FFA Fair.

BY ENTERING AND EXHIBITING AT THE POWESHIEK COUNTY 4H/FFA FAIR YOU ARE AGREEING TO ABIDE BY ALL RULES AND REGULATIONS INCLUDING THE IOWA CODE OF ETHICS.

- 1. Admission to all exhibits, lectures and demonstrations is free.
- 2. The fairboard reserves the final and absolute right to interpret all rules and regulations. This includes the ability to arbitrarily settle and determine all matters, questions, and differences connected with or incident to the fair.
- 3. Care will be taken to secure the safety of stock and exhibits but the fair association will not be responsible for any loss or damage that may occur.
- 4. The fair board reserves the right to reject for cause any exhibit.
- 5. All classes will be placed in blue, red or white groups unless it is a non-premium/non ribbon class. A project awarded a blue ribbon is considered above average, red ribbon is average and white ribbon is a little below average. The judge's ribbon placing is FINAL. If you have any questions, please contact the Extension Office or the fair office.
- 6. 4-H/FFA classes are open to current members of Poweshiek County 4-H clubs or FFA chapters who are in good standing with their respective organizations. Associate (younger then 4th grade) members are not eligible to exhibit at the fair unless they are a member of Clover Kids. However, they may exhibit in the Open Class.
- 7. IMPORTANT! All livestock class entry forms must be turned in to the fair office in Grinnell by June 15. Entries may be sent by mail or dropped off. Do not send or drop off entries at the Extension Office. Each entry submitted to the fair office after June 15 will be charged a \$5.00 late fee per division. ATTENTION: Absolutely NO livestock class entries will be accepted after July 1. NO EXCUSES!! Only livestock class entry forms obtained at poweshiekcountyfair.org will be accepted.

- 8. Superintendents must be at least 19 years of age and a non-exhibitor at the Poweshiek County Fair. Superintendents will have complete charge of their respective divisions, including stall and exhibit arrangements. However, this does NOT include changing or bending rules and regulations! Superintendents do not have the authority to make the decision as to an exhibitors eligibility to show. A minimum of 3 fairboard directors must be informed of any issue that may result in an exhibitor not being eligible. Superintendents will report rule violations & other issues directly to fairboard directors.
- 9. All 4-H & FFA exhibits must comply with the rules set by this fairbook in order to show. 10. All livestock will be in the barns on the fairgrounds until noon Monday, July 19th. All non-livestock exhibits are to be in place on the fairgrounds until 10 a.m. Monday, July 19th. Any exhibitor removing livestock or other exhibits before this time, without the consent of the fairboard, will forfeit ALL awards and premiums received on each project removed.
- 11. No alcoholic beverages will be allowed on the fairgrounds during the county fair. 4-H/FFA members involved with alcoholic beverages will be evicted from the fairgrounds and all awards including plaques, ribbons and premiums will be withheld. No project will be accepted for an exhibit if an alcoholic beverage or container has been used in any part of the exhibit.
- 12. 4H members may exhibit at the Poweshiek County Fair until the year of high school graduation or age 19. Exhibitors may continue to exhibit at the Poweshiek County Fair to the age of 21 as active FFA members. All rules and regulations apply. Please contact the fair office for clarification. Exhibitors show per grade level completed and/or age: Junior grades 4-6, Intermediate grades 7 & 8, Senior grades 9-12/FFA to age 21.
- 13. Profanity is not to be used by exhibitors at any time.
- 14. Anyone owing money to the Poweshiek County Fair Association from the previous fair(s) must make payment in full before being allowed to buy woodchips or camp at the current fair.
- 15. Anyone that has been suspended from exhibiting at the Iowa State Fair will be suspended from showing at the Poweshiek County 4-H/FFA Fair.
- 16. No one is allowed in the barns between midnight and 5:00 AM except superintendents, security personnel and fair board directors.
- 17. **NOTICE:** Any project offered for sale in an auction is considered to have changed ownership even if bought back by the original owner or if the owner refuses a bid or says, "no sale". All projects/animals offered for sale are terminated as 4H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. THIS RULING COMES FROM THE STATE 4H AND FFA RULES
- 18. Youth for the Quality Care of Animals/YQCA training is required for beef, dairy, meat goat, poultry, rabbit, sheep and swine exhibitors at the County Fair. Contact the Poweshiek Co. Extension Office for information on YQCA.

General Rules for Conference Judging

- 1. Please note general, departmental and division rules.
- 2. Dress Code: see Poweshiek County Fair General Information section
- 3. Clubs will be designated a time to bring all exhibits including Ag Dept Horticulture Class 10230 and County Fair Horticulture Class exhibits on Saturday, July 10th. Exhibits will be judged in conference with the judge and member at the designated time. Leaders and members are encouraged to be present for the judging, other interested persons and members are welcome. Judging will begin at 9 a.m.
- 4. Exhibits will be evaluated with consideration given for the knowledge and abilities of the exhibitor as shown in conference with the judge. Parents, grandparents etc. are welcome to sit in on the conference with the judge but are not to participate.
- 5. There are no limits on the number of exhibits that may be brought to the fair except in class 10320 photography. The limit of 6 photography projects per exhibitor remains and will be enforced.
- 6. Each entry must be labeled in an inconspicuous place with the class number, exhibitor name, school grade/FFA age and club name.
- 7. Blue, red or white ribbons will be awarded to exhibitors on the basis of conference judging. Outstanding exhibits will be awarded purple ribbons and state fair exhibits will be awarded purple rosettes. Yellow ribbons denote those exhibits strongly considered for state fair. Not all exhibits being considered for state fair will receive a yellow ribbon.
- 8. The judge's ribbon placing is FINAL.
- 9. State fair regulation Only exhibits shown by 4-H members that have completed 5th grade thru 12th grade (or equivalent) are eligible to be considered for state fair. Exception: Group exhibits from an entire club may include 4th grade members.
- 10. No Entry fee is required. The exhibit should be selected at a county event. All entries must be made in the name of the county and certified by an Extension Staff member.
- 11. Exhibits that do not comply with the class description, size guidelines, copyright restrictions, safety and approved methods will be disqualified and not put on public display.
- 12. Following the county fair, all exhibits that are chosen to go to the Iowa State Fair must be taken home by the exhibitor. **NO STATE FAIR EXHIBITS WILL BE LEFT AT THE FAIRGROUNDS.** Exhibitors will be responsible for getting their exhibits to the Extension Office following the county fair. Check with the Extension Office for the deadline for bringing in your projects.

- 13. Exhibit classes are broad categories. To plan exhibits, 4-Hers are encouraged to use "Hot Sheets", project guides and program materials. "Hot Sheets" are located on the state 4-H website http://www.extension.iastate.edu/4h/projects or they may be obtained from your leader. Each "Hot Sheet" allows for exploration of a project by providing information, resources and exhibit ideas. An exhibit can represent a part or all of the learning involved in the respective project.
- 14. Eligible exhibits are an outgrowth of work done as a planned part of the 4-H'ers participation in 4-H projects or programs during the current 4-H year. Exhibits can be done by an individual or group and may represent all or part of the learning in the project or program. Exhibits might be, but are not limited to an actual product, poster, display box, report, notebook, model, videotape, audiocassette, etc.
- 15. The 4-Her's goal and applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, workmanship, techniques, general appearance and design. Exhibitors will receive written evaluation comments on the exhibits and a blue, red or white exhibitor's ribbon. Refer to exhibit class evaluation rubrics for detailed evaluation criteria in each class. Rubrics are located on each 4-H project page at https://www.extension.iastate.edu/4h/exhibit-tip-sheets
- 16. A written explanation, an audiocassette or videotape answering the following questions must accompany the completed project when being judged at the county fair:
 - a. What did you plan or learn to do?
 - b. What steps did you take to learn or do this? Explain what you did so it is easily understood. The judge wants to know and understand the steps you used to make your exhibit.
 - c. What were the most important things you learned?

This form may be found on the Iowa 4-H project website http://www.extension.iastate.edu/4h/projects within each project page ****Check for additional requirements in exhibit classes for food and nutrition, home improvement, photography and visual art classes.

- 17. If the exhibitor chooses a display to illustrate what was learned: Posters may not exceed 24" x 36" in size. Chart boards, graph boards, project presentation boards, model displays etc may not exceed 48" x 48" in size. Maximum size is determined by measuring the flat (unfolded) dimensions. Display boxes may not exceed 28" x 22" in height or width and 12" in depth.
- 18. Endangered or threatened plants and animals (includes insects) or songbirds feathers and nests may NOT be used in any exhibit. Game animals "legally taken," are acceptable. Live specimens of noxious weeds or invasive species are NOT permitted in any exhibit. Dried specimens are acceptable to use in exhibits.
- 19. Copyrighted materials and designs may not be used in an exhibit that is presented as original work by the exhibitor. Exhibitors must include permission from the copyright holder/owner

when using copyrighted materials. Exhibitors must give proper credit to the original source of all materials/designs used in the exhibit. (See also special rules for Visual Arts and general copyright information for 4-H members) Original use by 4-H'er of copyright materials cannot be used in 4-H exhibits. Those without permission cannot be displayed.

- 20. All outdoor exhibits MUST be taken home after conference judging. They MUST be brought back to the fair before or by 8 a.m. opening day of the fair for display.
- 21. All exhibits, activities and programs must represent appropriate safety procedures in the development of the exhibit and during the evaluation process. This includes static exhibits and activities revolving around the communications program.
- 22. Project Sale: Any livestock or non-livestock project that has been judged and exhibited at the current fair may be sold through the project sale on Monday, July 19th. All non-livestock projects will be sold at the beginning of the sale. Exhibitors may ONLY have two (2) sales for non-livestock projects. All projects must be signed-up to sell by 6:00 p.m. SUNDAY, JULY 18th or they will not be eligible to sell. See Swine rule #12 for sale information. NO EXCUSES! NO EXCEPTIONS! Exhibitors selling non-livestock projects need to sign up on the poster near the south wall of the exhibit area.
- 23. **NOTICE:** Any project offered for sale in an auction is considered to have changed ownership even if bought back by the original owner or if the owner refuses a bid or says "no sale". All projects/animals offered for sale are terminated as 4H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. THIS RULING COMES FROM THE STATE 4H AND FFA RULES.
- 24. Exhibitors in 4-H classes are not eligible to exhibit in a similar department of the FFA divisions or vice-versa. See also "4-H Department General Rules & Regulations". Exhibits previously entered in an FFA Ag Science Fair or any other FFA event or competition may not be entered in any 4-H exhibit class.

General Communication Event Program Rules and Regulations

- 1. 4-H members who have completed 5th grade through 12th grade (or that equivalent) in 2021 are eligible to participate at the Iowa State Fair. Exception: Share-The-Fun and Extemporaneous Speaking See event rules for age guidelines.
- 2. Educational Presentations and Working Exhibits may be given by one or more 4-H member Teams consisting of youth of mixed grades will be subject to the time limits based on the grade of the member in the highest grade level (i.e. a team with a 5th grader and an 8th grader will use the times for the intermediate/senior class).
- 3. Topics selected by the 4-H member(s) should be an outgrowth of his/her 4-H experience(s). Topics should be appropriate for presentation to a general audience.
- 4. Educational Presentation, Working Exhibit, and Extemporaneous Speaking participants cannot be involved in another event (communication event, clothing programs, livestock show or judging) during the half-day they are scheduled to participate in their program. Share-The-Fun participants cannot be involved in another event from 30 minutes prior to the beginning of the schedule show to 15 minutes following the show.
- 5. All participants are required to attend the scheduled orientation session prior to participating in their event. (Times subject to change.)
 - Educational Presentations: 8:30 AM or 1:00 PM (12 21)
 - Working Exhibits: 8:30 AM or 1:00 PM (12 21)
 - Share-The-Fun: 20 minutes prior to the show, normally Noon and 5:00 PM

 times may vary (12 21)
 - Extemporaneous Speaking: 8:30 AM or 1:00 PM Monday August 16/ Tuesday, August 17/Thursday, August 19; 8:30 AM Sunday, August22
- 6. Only presenters are allowed in the Educational Presentation, Working Exhibit and Extemporaneous Speaking preparation rooms.
- 7. Educational Presentation and Working Exhibit participants will be involved in a "peer evaluation program".
- 8. All 4-H Educational Presentation, Working Exhibit, and Extemporaneous Speaking participants will be given Certificates of Recognition and written evaluation comments. Seals of Merit will be presented to those giving outstanding presentations. Seals of Excellence will be presented to those giving superior presentations. Share-The-Fun participants will receive participation ribbons and a written critique of the performance. Participants are expected to be present for awards given at the close of the event session.
- 9. Participants in the 4-H Communication Programs are expected to wear appropriate clothing representative of the 4-H Youth Program and/or the topic of the presentation.
- 10. 4-H members must use sanitary and safe procedures and methods at all times. Educational Presentations and Working Exhibits involving food must follow established food safety guidelines.
- 11. All participants are expected to comply with all copyright/trademark regulations. Copyrighted material may not be distributed without permission.
- 12. A \$12.00 fee per entry will be billed to the county. Entries should be selected from a county communication event program.
- 13. Allocated premiums will be paid to counties for distribution based on the participation in the 4-H Educational Presentation, Working Exhibit, and Extemporaneous Speaking opportunities. There will be no premium allocations for Share-The-Fun.

EDUCATIONAL PRESENTATION

Purpose – Provide an opportunity for 4-H members to demonstrate communication skills by presenting knowledge, information or a process to an audience in order to gain a desired response.

11101 Juniors 11102 Int. & Sr.

Presentations should be an outgrowth of the member's 4-H experience during the current year. Educational presentation may be given by one or more 4-H members. The topic content of the presentation should determine its length, but intermediate and senior presentations must not exceed twenty (20) minutes. Junior presentations must not exceed fifteen (15) minutes. Participants must turn in a completed Educational Presentation Report form during event check-in.

SHARE-THE-FUN

Purpose – Provide an opportunity for 4-H members to share their skills and talents before an audience purely for the sake of enjoyment.

11300

- 1. Eligibility: All 4-H members may participate in this event. Only those 4-H members who have completed 5th grade through 12th grade (or that equivalent) in 2021 may advance to the State Fair. Exception: If the Share-The-Fun act involves a whole club, the following criteria must be applied to determine if the club can be entered in the Share-The-Fun Program at the Iowa State Fair: At least 80 % of the performing group must have completed 5th through 12th grade in 2021
- 2. Share-The-Fun performances must not exceed 6 minutes in length.
- 3. Skits, songs, stunts, short one-act plays, dance and other entertainment will be acceptable. All performances must be appropriate for presentation to a general audience.
- 4. All performers must turn in a completed 4-H Share-The-Fun Report form at event check-in to confirm stage setup, cue music etc.

WORKING EXHIBIT DEPARTMENT

Purpose: Provide an opportunity for 4-H members to communicate, interact with, and teach an audience in an informal and experiential way.

Working Exhibit Rules

- 1. Time limit: All participants/teams will be scheduled for a30 minute period...
- 2. Participants must turn in a completed Working Exhibit Report form during event check-in.
- 3. 4-H members may participate in one Working Exhibit per year at the Iowa State Fair.

11200 Working Exhibit

EXTEMPORANEOUS SPEAKING

Purpose – Encourage the development of communication skills by providing an opportunity to think, organize thoughts, prepare a speech and response to questions when given a limited amount of preparation time.

11400 Participants must be senior 4-H members – completed 9th through 12th grade (or that equivalent) in 2021

- a. Thirty minutes before the program, each participant will draw three of the available topics, selecting one to speak on. The other 2 topics drawn but not chosen will be returned to the available topics for the other participants. The general nature of the topics will relate to 4-H.
- b. A preparation room will be provided. A participant may not leave the preparation room until it is time to speak, nor may a participant receive help from a parent, leader other adult or any other youth.
- c. All reference material will be screened by a program official on the following basis: Participant may bring his/her own books, magazines, or newspaper clippings for reference during the thirty minutes of preparation.
- d. Each speech shall be the result of the 4-H members own efforts using approved reference material that a participant may bring to the preparation room. No other assistance may be provided. Plain 3"x5" note cards will be provided for each participant in the preparation room. If notes are used, the 3"x5" note cards provided must be used in delivering the speech.
- e. Only notes made during the preparation period may be used.
- f. Each speech shall not be less than four, or more than six minutes with five minutes additional time allowed for related questions, which shall be asked by the judge. The participant will be shown timecards in an ascending order (1, 2, 3, 4, 5) by the timekeeper. "Stop" will be said at six (6) minutes.
- g. The program timekeeper will introduce each participant by name. The participant will be expected to introduce his/her speech by title only.
- h. Participants are not permitted to use any props, gadgets, posters, or audiovisuals of any sort. A podium will not be available.

Speeches will be evaluated using the following criteria:

- A. Content related to topic
- B. Knowledge of the subject
- C. Organization of material
- D. Power of expression
- E. Voice
- F. Stage presence
- G. General effect
- H. Response to questions

A judge's critique/conference with each participant will be included as a part of the program.

IOWA STATE FAIR COMMUNICATIONS JUDGING: Exhibitors advancing to the State Fair must make arrangements through the Extension Office.

CLOTHING EVENT

Check upcoming 4-H newsletters for entry & entry fee information. General Overview

- 1. Each youth may only participate in the 4-H wardrobe Clothing Event with one entry in one class per year. However, youth may be selected to participate multiple years for any given class, even if they participated in that class in previous years.
- 2. Each county may send the following number of participants in each class to represent their county, selected from each of the county's events:
 - a. Fashion Revue Class: Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
 - b. \$15 Challenge Class: Three participants total with no more than one (1) participant with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
 - c. Clothing Selection Class: Three participants total with no more than one (1) participant with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
- 3. The categories in each class are simply for entry limit purposes. All entries in each class will be judged together.
- 4. Participants must be in the senior 4-H designated level (completed grades 9 12 in 2021) in order to qualify and advance to the State Fair.
- 5. Outfits or accessories which will be worn during the State 4-H wardrobe Clothing Event may not be entered as another 4-H Iowa State Fair exhibit.
- 6. Participants must bring the garment or outfit they purchased or created, and accessories, to the State 4-H wardrobe Clothing Event.
- 7. Participants should submit only the materials requested for each class (report form and photo— for ALL classes plus a receipt for \$15 challenge). If additional materials are sent with the entry or brought to the conference judging, they will not be considered.
- 8. Participant Report Forms must be uploaded by county staff by July 31, 2021. Participants should abide by county deadlines for submitting paperwork for entry.
- 9. A \$30 registration fee is required for each participant entry. Counties will be billed following the Iowa State Fair.
- 10. All participants must participate in all wardrobe Clothing Event activities at the times scheduled for their county unless the 4-H member is involved in another Iowa State Fair 4-H activity at the same time with a non-flexible schedule, with pre-approval.

Class

960 Fashion Revue (premium class)

- 1. The purpose of this category is to encourage the sewing of a personal garment or outfit.
- 2. Consideration is given to fit, color, style, suitability, attractiveness, quality of construction, stage presentation, and required care.

Pâge 28

- 3. Youth participants will model a garment or outfit they constructed, hand-knitted, machine-knitted, or crocheted during the current 4-H year.
- 4. A garment or outfit consists of one to three pieces such as, but not limited to, party clothes, tailored suits, vest, slacks, shirt, skirt, active sportswear and/or coats.
- 5. Blouses, shirts, and sweaters are usually considered as garments. If they are used to complete an outfit, they may be constructed or selected.
- 6. All other accessories and undergarments may be constructed or selected.
- 7. Participants may not exhibit their constructed item used for fashion review in a clothing division class at the County Fair.

961 Clothing Selection (premium class)

- 1. The purpose of this category is to select and/or purchase an outfit that represents the 4-H member goal or intended use for the selected outfit.
- 2. Judging is based on fit, color, style, suitability, attractiveness, quality and construction features, stage presentation, required care, and cost comparison.
- 3. There is no consideration in the judging on the amount spent, only in the process of recordkeeping and reflection on the cost of the individual items as a part of the process.
- 4. Outfits may be purchased at a department store, boutique, online store, sidewalk sales, retail shops or mall stores. Outfits may also be purchased at garage sales or other secondhand venues with a total price of over \$15. Outfits may be gifts, hand-me-downs, relative or friend's modern or vintage clothing, or existing personal clothing, as long as the 4-H member actually selected the item as part of this specific outfit for the stated purpose.
- 5. Home-sewn clothing that was not sewn specifically for the participant are acceptable, such as purchases from a used clothing store.
- 6. Any 4-H member may enter clothing selection. Participants must be present for judging.
- 7. All contestants must fill out a clothing selection form. Forms are available at the Extension Office or online at www.extension.iastate.edu/poweshiek/hidsteens.htm.
- 8. State fair contestants will be selected to represent Poweshiek County at the state fair clothing selection program. Each county must send one (1) girl and one (1) boy who have completed grades 9-12.
- 9. Participants may not exhibit any portion of their outfit used for Clothing Selection in a clothing division class the County Fair.

962 \$15 CHALLENGE (premium class)

All participants (male or female) must:

- 1. This category is designed to expand the 4-H member's shopping experience to shopping venues emphasizing recycling, reducing and reusing. Outfits must be purchased at a garage sale, consignment store, Goodwill, Salvation Army, or similar place.
- 2. Online venues are allowed, must be second-hand in nature. Shipping and handling are not included in the total calculations.

- 3. Traditional shopping venues may not be used, regardless of a low regular or sale price. Hand-me-downs or clothing as gifts do not qualify, but may be entered in Clothing Selection if 4-H member selected the items to meet a specific purpose/goal.
- 4. Fifteen dollars is the purchase price limit including tax. However, some secondhand stores and venues do not typically charge sales tax.
- 5. Receipt(s) for every item included as a part of the calculated total must be submitted with the entry. A garage sale receipt can be a piece of paper with the name of the location such as "Jane Doe garage sale", date, amount paid, and signature of person selling at the garage sale. If the outfit was free at a garage sale, "free" can be listed on the report form and on the receipt. Failure to provide receipts will be reflected in the evaluation.
- 6. An outfit consists of major clothing pieces such as a shirt and pants or a dress. Shoes, undergarments and accessories are not included in the \$15 purchase price limit.
- 7. Alterations are permitted to achieve a desired look or fit.
- 8. There are no additional considerations for an outfit that cost less than \$15.
- 9. The outfit pieces should be purchased to meet the 4-H member's goal or intended use for the purchased outfit, and the 4-H member should have had an experience in choosing shopping alternatives, evaluating fit, quality and construction features, price, and cost comparison.
- 10. Participants may not exhibit any portion of their outfit used for \$15 Challenge in a clothing division class at the County Fair.

Clothing Special Recognition

- a. All wardrobe Clothing Event participants will receive a green participation ribbon presented at the public fashion show held at the Iowa State Fair.
- b. The top five (5) entries in each class (Fashion Revue, Clothing Selection, \$15 Challenge) will receive an award plaque
- c. Special Recognition will be presented by the Central Iowa Chapter, American Sewing Guild to two individuals who exhibit outstanding sewing skills in the Fashion Revue class.
- d. The Iowa State University College of Human Sciences' Apparel Merchandising and Design Program and Trend Magazine student organization will present an "On Trend Award" to one participant whose garment incorporates this year's clothing trends.
- e. One inspiring participant (must have been selected as top five in class), and who has expressed an interest in furthering their education in the area of textiles and clothing, hospitality management, or consumer sciences will be awarded a \$500 scholarship to the Iowa State University College of Human Sciences' Department of Apparel, Educational Studies, and Hospitality Management.

FOOD EVENT

Check upcoming 4H newsletters for entry information

963 Food Challenge (premium class)

- 1. Any 4-H member may enter the Food Challenge. It is a county event only; no one will be advancing to another level of competition.
- 2. Register by submitting your recipe to the Extension Office. **Check 4H newsletter for entry information.**
- 3. At the Food Challenge, the participant will prepare a recipe in 45 minutes or less. Categories are main dish, salad, side dish, dessert, snack or beverage. The judge will evaluate food safety in handling and preparation and conference judging will take place after final product presentation.

Participants do not need to talk during the food preparation.

- 4. Participants will receive blue, red or white ribbon awards.
- 5. Each participant can bring up to 3 prepared items (if they have carrot, pepper, onion and celery in the dish, they may precut the amount for 2 of the items and then cut the other two in front of the judge). Certain items may be pre- measured as well (as long as you show the judge one example of you measuring something).

964 Table Setting Challenge (premium class)

- 1. Any exhibitor may enter Table Setting Challenge. This is a County Only Event.
- 2. 4Her's may work alone or in a team to create a themed table setting.
- 3. Table setting should include:
 - a. menu (no food)
 - b. proper table service and glassware
 - c. themed decorations
 - d. You are encouraged to dress in accordance with your theme.
- 4. Conference judging will take place during the course of Event Day.
 - a. Present to the judge your theme and menu
 - b. Express knowledge of food, nutrition and food safety

FFA members may exhibit projects in the conference judging classes. FFA exhibits are not eligible for state fair selection as these classes are 4-H ONLY classes. If FFA members wish to exhibit at the state fair, they will need to contact their advisor.

Exhibitors should move from project area to project area when finished in one area.

Please be sure to read General Conference Rules. All entries are required to answer the three goals questions to be eligible for state fair.

Please be sure to pick up a number card when you arrive to your judging area and wait until your number has been called for judging.

Please be patient until your turn arrives.

Pet judging will be from 9:00 a.m. to 11:00 A.M. only (Clover Kids will have their pets judged during this time).

Horticulture will be from 9:00 a.m. to Noon. If you have Horticulture projects, you will need to come at this time regardless of when your club is scheduled.

Judges will be given a lunch break from 12:00 – 12:30p.m.

Class Descriptions

Most exhibit classes have specific guidelines and requirements that will be included in the judging process. Members are highly encouraged to go to www.extension.iastate.edu/4h/exhibit-tip-sheets to find information about judging criteria for exhibits that they create from their 4-H project learning.

ANIMALS

10110 Animal Science

An exhibit (other than the animal itself) that shows the learning about a large or small animal including beef, dairy cattle, dairy goats, dogs, horse & pony, meat goats, pets, poultry, rabbits, sheep and swine. Ownership of an animal is not required.

10120 Veterinary Science

An exhibit that shows learning about keeping animals healthy, animal diseases, animal/human health interaction, or other learning related to Veterinary Science.

AGRICULTURE AND NATURAL RESOURCES

10210 Crop Production & Plant Science

An exhibit that shows learning about the growth, use, and value of field crops, plant growth, soils and soil fertility, or any other learning related to Crop Production and Plant Science.

10220 Conservation, Environment, and Sustainability

An exhibit that shows the connections between humans and their environment including energy, energy conservation, stewardship, conservation, creating habitat, etc.

10222 Entomology

Any exhibit that shows learning from an entomology or bee project (excluding live specimens) that is an outgrowth or an entomology or bee project learning experience. Includes specimen collections and may include products (ex: honey) or equipment as part of the display.

10224 Fish and Wildlife

Any exhibit that shows learning about a fish and/or wildlife project or program such as identification, habitats, harvest, taxidermy, etc. Any specimens must have been legally taken and must include information about date and location of harvest, and who the specimen was acquired from if not self-harvested. Feral pigs (including Russian/European Boar) are NOT permitted in taxidermy exhibits.

10226 Forestry

Any exhibit, including collections, that show learning from participation in a forestry project or program.

10230 Horticulture and Plant Science

An exhibit that shows learning about the growth, use and value of plants, soils small fruit production, vegetable and flower gardens, plant nutrition, careers etc. (Garden crops and herbs are exhibited in classes in the 4-H Horticulture Department under 4-H Livestock.)

Page 33

10235 Home Grounds Improvement

An exhibit that shows learning about landscape plans, selection of landscape plants, ornamental garden features, home yard improvement, storage sheds, careers etc.

10240 Outdoor Adventures

An exhibit that shows learning about backpacking, biking, camping, canoeing, fishing, hiking or other outdoor activities.

10250 Safety and Education in Shooting Sports

An exhibit that shows learning about safe and responsible use of firearms and archery equipment or wildlife management. (The exhibit may not include actual firearms, archery equipment allowed if tips are removed from arrows)

10260 Other Agriculture and Natural Resources

An exhibit that shows learning about agriculture or natural resources and does not fit in any of the other classes listed above.

CREATIVE ARTS

10310 Music

An exhibit that shows learning about musical performance, composition and arrangements, instruments, musical styles or history.

10320 Photography – <u>Limit of 6 in this class</u>

An exhibit, either photo(s) or an educational display that shows learning about photography from choosing a camera to modifying your photo. Still photos only, not video.

Photography Special Rules:

- Photographs may be either black and white or color. They may be p rocessed from negatives, slides, or digital cameras and computer manipulation programs. Photographs must have been taken since your county fair of the previous year.
- 2. Photographs should be a minimum of 5" x 7" Finished size (including mounting/matting) of single photographs may not exceed 11" x 14". Exception: Panoramic photos must not exceed 24" in length.
- 3. All photographs MUST be mounted and/or matted.
- 4. Mounted photos can be (a) flush-mounted [no board showing] on mounting board, or (b) with mount borders [window mat or flat mount directly on board]. Exhibitors may cut their own mounting boards, use ready-cut window mats or have matting done professionally.
 - 4-H members are responsible for design decisions such as border, color and size. **Framed photographs (including floating frames) will not be judged.**
- 5. Non-mounted photos may be exhibited in a clear plastic covering.
- 6. A series is a group of photographs or slides [3 to 5] that are related or tell a step-by-step story. Photographs must be mounted together in story order or sequence. Finished size of individual photographs in a series should not exceed 6" x 8".
- 7. Digitally altered photos should include a copy of the photo before changes.

- 8. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.
- 9. Photographs depicting unsafe practices or illegal activities will not be displayed.
- 10. Iowa State Fair 4-H photography exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits. Label may be found at www.extension.iastate.edu/poweshiek/4h
- 11. Exhibitors entered in 4-H Photography are not eligible to exhibit in the FFA Photography show and vice-versa.

10325 Digital Photography Exhibit

<u>A photo or series of photos submitted electronically, not printed.</u> Photos in this class will be submitted, viewed, evaluated and displayed electronically. Submission will be via uploaded to Fair Entry Data System.

Digital Photography Exhibit Special Rules:

- 1. Photographs may be either black and white or color.
- 2. Photographs will not be printed.
- 3. Entries may be a single photo or a series of photos. A series is a group of photographs [3 to 5] that are related or tell a step-by-step story. Series photo entries must have all photos in the series viewable at the same time.
- 4. Photos entered should be submitted in the highest resolution possible. A finished file size of 1 MB 3 MB is recommended.
- 5. Photos should be submitted in an acceptable and commonly used format for ease of viewing.
- 6. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.
- 7. Photographs depicting unsafe practices or illegal activities will not be displayed.
- 8. Iowa State Fair 4-H photography exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits. The Photo Exhibit Label may be submitted electronically with the photo entry.
- 9. Photos entered in this class will be evaluated on the same evaluation criteria used for printed photographs.
- 10. Exhibitors entered in 4-H Photography are not eligible to exhibit in the FFA Photography show and vice-versa.

10340 Creative Photography

A single photograph or photographic image that has been created with an alternative photographic process or a photograph that was creatively edited or modified beyond reality in a creative, imaginative and experimental way to make it more interesting and visually engaging. Could be a composite of multiple overlapped photographs.

Creative Photography Special Rules:

- 1. Photograph/image may be mounted/matted or submitted (uploaded) as a digital image.
- 2. Photograph/Image if mounted must be mounted on foam core no smaller than 4"x4" and no larger than 10" x 10" in height and width. No matting and no framing are allowed, put your creativity into the photography!
- 3. Photograph/Image can be created from film negative, digital negative, or digitally manipulated in computer. Page 35

- 4. Photograph must be on photo paper, canvas, or other flat material.
- 5. Exhibit must have Photo Exhibit Label on back with required information for photo exhibits. Include information about the processes used.
- 6. Subject matter must be in good taste and be appropriate for public display in a 4-H setting, photographs depicting unsafe practices or illegal activities will not be displayed.

10345 Photography Idea/Educational Display

An exhibit that demonstrates learning about photography that does not fit into any previous photography class. This class includes photos printed on canvas, fabric, ceramic etc. as part of an educational display showing learning about printing techniques, display, merchandising etc.

10350 Visual Arts Original Art- An exhibit that shows learning through creation of original art. Original art is a one of a kind, non replicable design of your creation. By using one medium or a combination, an individual creates an authentic work of art that is not recognizable as another's work. You must explain the application of the most relevant design element(s) and art principle(s) featured in this exhibit. Describe your inspirations, reasons, feelings, and/or motives for creating this work of art.

10355 Visual Arts -Design, Process, or Technique Exploration — This exploration class emphasizes process and provides an individual the opportunity to explore a medium, practice a skill, or study and apply elements and principles of art and design. An explanation of the application of design elements or art principles used when making the exhibit must be included. This exhibit may be an object, portfolio, display, poster, or organized sketchbook. If a non-original design source is used, its origin (where the idea was found, any pictures, sketches, etc.) must still be credited, acknowledged or have copyright permission obtained. See visual arts special rule #5.

10360 Visual Arts - Other Visual Art Ideas/Topics — Exhibits might include the study and research about an individual artist, style, craft, business or marketing process, planning group tour, career options, etc

Visual Arts Special Rules:

- Exhibits made from kits or preformed molds will not be accepted Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.
- 2. If the exhibit is a finished art object, the source or inspiration of the design, design sketches, or other process for creating the object and design must be included. For additional information see the Visual Arts and Design Elements & Art principles Exhibit Tip Sheets at https://www.extension.iastate.edu/4h/exhibit-tip-sheets.
- 3. If the exhibit is a finished art object information must be included e xplaining the application of design elements and art principles used in creation of the work.
- 4. Original works of art must be a creative expression of a design unique to the artist, or represent a significant modification to an existing design to make a new and original statement by the artist.
- 5. Exhibition of derivative works created by a 4-H member is prohibited without the written permission of the original copyright holder/owner. Use of copyrighted or trademarked designs, images, logos, or materials in 4-H visual arts exhibits is prohibited unless written permission has been obtained from the copyright or trademark holder/owner. For additional information, see 4-H Exhibit Copyright Information at https://www.extension.iastate.edu/4h/visual-art.

FAMILY & CONSUMER SCIENCES

Clothing and Fashion Special Rule:

- 1. Outfits or accessories which will be worn during the wardrobe Clothing Event may not be entered as a 4-H Iowa State Fair exhibit.
- 2. Exhibits in classes 10420 and 10422 must include information about application of design elements and art principles. Exhibits in class 10424 should include information about application of design elements and art principles if appropriate for the exhibit.

10410 Child Development

An exhibit that shows learning about children. Examples: childcare, growth and development, safety and health, children with special needs, and careers in child development. Exhibits that include items intended for use with children (books, toys, learning games, babysitting kits, etc.) should include information about what you have learned 1) about children while creating and using the exhibit or 2) what the child(ren) learned from use of the item(s) in the exhibit.

10420 Clothing and Fashion – Constructed/Sewn Garments & Accessories A constructed garment or accessory (sewn, knitted, crocheted or other process) that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics and clothing care. Exhibits must be intended to be worn by humans.

10422 Clothing and Fashion – Purchased Garments & Accessories

Purchased garments or accessories that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics and clothing care. Exhibits must be intended to be worn by humans.

10424 Clothing and Fashion - Other Ideas/Educational Exhibits

Any other educational exhibit that shows learning about clothing and fashion including but not limited to design illustrations, exploration of clothing styles, careers, clothing care etc.

10430 Consumer Management

An exhibit that shows learning through savvy budgeting, comparison shopping, money management and consumer rights and responsibilities.

10440 Food & Nutrition - Prepared Product

An exhibit of a prepared or preserved food product that shows skills or learning about cooking, baking, eating and choosing healthy foods, safety practices or food preservation through the making of a prepared or preserved food product. See Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" at https://store.extension.iastate.edu/product/6434 for additional information regarding prepared and preserved food products.

10442 Food & Nutrition - Preserved Product

An exhibit of a preserved food product that shows skills or learning about food preservation through the making of a prepared or preserved food product. Processed honey may be exhibited in this class. The "Food Preservation Exhibit Label" will be revised. A "Honey Label" will be made available for processed honey exhibits. Both labels will be available on the 4-H Iowa State Fair Exhibits web page and the Food & Nutrition project web page. See Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" at https://store.extension.iastate.edu/product/6434 for additional information regarding preserved food products

10445 Food & Nutrition - Educational Display

An educational exhibit (poster, report, display) that shows skills or learning about cooking, baking, eating and choosing healthy foods, meal planning & service, safety practices, or food preservation. See Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" for additional information regarding prepared and preserved food products. Exhibits showing learning about meal planning & service must include a menu. "Planning for special meals, include table service, can be a fun learning experience. When these types of exhibits are part of a Food & Nutrition exhibit, menu information is an expected part of the project learning. A 4-H member who desires to only plan and prepare the table service and decorations, but not the meal, should exhibit in Class 10460 Home Improvement.

Food & Nutrition Special Rules:

- 1. Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged or displayed.
- 2. All food products/exhibits should be appropriate for human consumption.
- 3. Food product exhibits must be prepared, baked or cooked using only food grade utensils and containers.
- 4. Products that require refrigeration will not be accepted, judged or displayed.
- 5. Meat jerky products are prohibited.
- 6. The recipe must be included for any prepared food exhibit; credit the source of the recipe.
- 7. Preserved foods must include the Food Preservation Exhibit Label.

 Only food processed after August 1, 2020 is acceptable. Current USDA and/or Iowa State University guidelines for home food preservation must be used. Processed honey must include the Honey Exhibit Label.
- 8. Preserved food exhibits must include two product samples. One will be opened for evaluation and discarded; the second will be placed on display and returned to the exhibitor. All perishable food products will be discarded when removed from display.
- 9. Prepared foods should be placed on a firm disposable plate or flat cardboard. Place food product exhibit in a reclose able plastic bag with entry tag fastened outside the bag. Recommended number of items to include with the exhibit:

 Cookies, cupcakes, bars, muffins, rolls, etc. four (4) to six (6) items
 Cakes, loafs, pies, etc. one (1) whole product.
- 10. The use of alcoholic beverages in the preparation or production of 4-H food exhibits is NOT permitted.

10450 Health

An exhibit that shows learning through food choices, safe activities and skills such as first aid and CPR, careers and healthy lifestyle choices.

10460 Home Improvement - An exhibit that shows learning in planning, improving and caring for your home living space, including extended personal living areas immediately adjacent to the home. Exhibits may include new or refinished/reclaimed/restored items. Exhibits showing learning about home design, furniture, home accessories, and fabrics must include information about how design elements and art principles were applied.

Home Improvement Special Rule

Items entered must be ready for display in the home: pictures framed, wall hangings and pictures ready to hang, etc. Make sure hangers are strong enough to support the item. Command Strips or other quick attach products are usually not adequate hangers. Items not ready for display will be dropped one ribbon placing.

10470 Sewing and Needle Arts

Constructed item (sewn, knitted, crocheted or other process) that shows learning and skill in sewing, knitting, crocheting or other needle arts. May include the construction of household items such as pillowcases, curtains, table runners, quilts, wall hangings or other items. Exhibits in this class are intended to be worn by humans.

10472 Sewing and Needle Arts – Other Ideas/Educational Exhibits Any other educational exhibit that shows learning about sewing and needle arts including but not limited to construction techniques, use and care of fabrics and fibers, design illustrations, decorative processes, careers.

Note: Exhibits in classes 10470 and 10472 should include information about application of design elements and art principles if appropriate for the exhibit.

10480 Other Family and Consumer Science

An exhibit that demonstrates learning about a family and consumer science topic that does not fit any previous Family & Consumer Science class listed.

Special Exhibition - \$10 MEAL CHALLENGE

10490 - \$10 Meal Challenge – Create a balanced, nutritious meal for family of four (4) that includes a serving from each of the five good groups for each person. Information regarding food groups and recommended daily servings can be found on the USDA MyPlate website www.choosemyplate.gov

Special Rules:

- 1. Each county may enter one (1) exhibit in this class.
- 2. All entries will receive an evaluation and participation ribbon.
- 3. Exhibit may be from an individual or group effort.
- 4. The meal must serve at least a family of four (4) people and total expense on receipt must not exceed \$10..
- 5. The meal must include a serving for each person from each of the five (5) food groups Fruit, Vegetable, Protein, Grain, Dairy.
- 6. The exhibit will be a poster (maximum size 20" x 30") that shows the menu (including portion size), meal type (breakfast, lunch, dinner), grocery receipt, and photos of the meal. Attach a copy of the \$10 Meal Challenge worksheet to the back of the poster. PERSONAL DEVELOPMENT

10510 Citizenship and Civic Engagement

An exhibit that shows learning about or contributing to your community, your country or your world.

10520 Communication

An exhibit that shows learning about written, oral, and visual communication skills in their many forms. Includes learning from participation in Theatre Arts projects or programs including puppets, stage design, etc. May include original creative writing, poetry, fiction and non-fiction, etc.

10530 4-H Poster Communication Exhibit

Special poster exhibit to visually tell a story or idea bout 4-H to the general public. Exhibitors must use one of the following themes:

- a. 4-H is... (open to 4-H members interpretation)
- b. Join 4-H
- c. 4-H Grows...(4-H.org national marketing theme)
- d. "Quest to Be Your Best" (2021 Iowa 4-H Youth Conference theme)
- e. How Do You 4-H? (adaptation of 2021 Iowa State Fair theme "How DoYou Fair?")

Poster Communication Special Rules:

- 1. Only one poster per 4-H member may be entered.
- 2. All posters must be designed on, or affixed to, standard poster board or foam core board size minimum of 14" x 20" or maximum of 15"x22".
- 3. Posters may be vertical or horizontal. Posters may be any medium watercolor, ink, crayon, acrylic, charcoal, and oils, collage.
- 4. Posters <u>cannot</u> be 3 dimensional. Materials used to make the poster may not extend more than 1/8 inch above the poster or foam core board.
- 5. Each poster **must** have a completed Poster Exhibit Entry Form attached to the back.
- 6. Posters cannot use copyrighted material or exact copies of other promotional designs, such as the Iowa 4-H Youth Conference theme logo.
- 7. 4-H member may include the 4-H Clover in the poster.
- 8. All 4-H Communication Poster participants will be given Certificates of Recognition and written evaluation comments. Outstanding posters will receive Seals of Merit. Superior posters will receive Seals of Excellence.

10540 Digital Storytelling

Any exhibit that demonstrates the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video.

10550 Leadership

An exhibit that shows learning about leadership skills and influencing others in a positive way.

10560 Self Determined

An exhibit that shows learning as part of your 4-H adventure and does not fit any other class.

SCIENCE, ENGINEERING & TECHNOLOGY

Exhibitors entered in the 4-H Science, Engineering & Technology classes may not enter in similar FFA Ag Mechanics classes and vice-versa.

10610 Mechanics

Any exhibit that shows skills or learning about general mechanics or engineering solutions or that involve a combination of skills.

10612 Automotive

Repaired or restored vehicle or educational display showing learning about an automotive idea including automotive maintenance, auto operations, auto safety, or automotive systems. (Note: vehicles will be on display at the Iowa State Fair one day only, Thursday August 12.)

10614 Electric

Constructed or repaired article or educational display that shows skills or learning about electric wiring, appliances, lighting, electrical energy sources, safety etc.

10615 Small Engine

Repaired or restored operating engine or educational display or other type exhibit that shows skills or learning about small engines. This class includes repaired or restored lawn tractors, small motorcycles, go-karts etc.

10616 Tractor

Repaired or restored tractor (or educational display showing learning related to tractors, tractor mechanics, tractor operations, or tractor safety. Note: A conference judging opportunity for exhibitors of repaired or restored tractors in class 10616 will be offered during exhibit check-in. (Conference judging may not be available during all check-in times.) Tractors will be displayed outside throughout the Iowa State Fair. Release time Sunday, August 22, after 7:00 p.m.)

10618 Welding

Constructed item or educational display that shows skills or learning about welding.

10620 Woodworking

Any exhibit that shows learning about wood, woodworking techniques and safe uses of woodworking tools and machines. Exhibits may include newly constructed or refinished/reclaimed/restored wood items.

10630 Science, Engineering & Technology

Any exhibit that shows learning about or helps explain how science and technology help us interact with the world. Topics include, biological and chemical sciences, computers & networking, earth & climate, geospatial mapping (GPS/GIS), or any other application of Science, Engineering or Technology.

10632 Aerospace

Educational display or other exhibit (including flyable models) showing learning about an aerospace idea or topic.

10634 Robotics

Educational display or other exhibit (including working robots) that shows learning about robotics and robotic systems.

COUNTY FAIR ONLY DEPARTMENT (not eligible for state fair)

500 Fun Foods: Any exhibit that does not fit in any other food class. The exhibit must be able to stay the duration of the fair without refrigeration. An example of a project is: Train engine made out of different types of candy (party favor). Let your imagination be your guide in the class and have fun with it!

100 Article Made From A Kit: Any article made from a kit.

PETS HEALTH REQUIREMENTS – No Health certificate required – if any questions regarding pet's health, the Official Fair Vet will be called. Cats and dogs must have a rabies vaccination certificate. FOR STATE FAIR, DISTRICT SHOWS AND EXHIBITIONS CONSULT THE 2021 HEALTH REQUIREMENTS FOR EXHIBITION OF LIVESTOCK, POULTRY AND BIRDS AT STATE FAIR, DISTRICT SHOWS AND EXHIBITIONS.

2021 HEALTH REQUIREMENTS FOR EXHIBITION OF LIVESTOCK, POULTRY AND BIRDS AT A COUNTY 4H/FFA FAIR EXHIBITION

ANY EVIDENCE OF WARTS, RINGWORM, FOOT ROT, PINK EYE, DRAINING ABSCESSES OR ANY OTHER CONTAGIOUS OR INFECTIOUS CONDITION WILL ELIMINATE THE ANIMAL FROM THE SHOW.

No individual Certificate of Veterinary Inspection will be required on Iowa origin animals or poultry exhibited at County 4-H/FFA FAIR, but the animals must be inspected when unloaded or shortly thereafter by an accredited veterinarian. Swine are required to be inspected either before being unloaded or before leaving a designated isolation and inspection area (prior to mixing with any other pigs). All animals moving from out of state into an Iowa county 4H/FFA fair must meet Iowa Animal and Livestock Importation requirements. Each show <u>must</u> have an official veterinarian.

Quarantined animals or animals from quarantined herds cannot be exhibited.

Official identification listed on a Certificate of Veterinary Inspection required for all cattle and bison of any age **coming from out of state** used for rodeos, recreational events, shows and exhibitions.

SWINE

All swine must originate from a herd or area not under quarantine and must be individually identified. All swine are required to have individual official identification. All 4-H and FFA tags bearing the US shield are official identification tags.

Swine originating outside of Iowa. All exhibitors must present a test record and Certificate of Veterinary Inspection that indicate that each swine has had a negative test for pseudorabies within 30 days prior to the show (individual show regulations may have more restrictive time restrictions), regardless of the status of the herd and show individual official identification on test report. Electronic identification will not be considered official identification for exhibition purposes. Swine exhibition requirements. "Swine exhibition" means an exhibit, demonstration, show or competition involving an event on the state fairgrounds, a county fair or other exhibition event. The sponsor of the exhibition must retain an Iowa licensed veterinarian to supervise the health of the swine at the exhibition location

The sponsor must electronically file the approved registration form and obtain approval from the state veterinarian at least 30 days before the event. The registration form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian and the date of the planned exhibition. Sales of swine will not be allowed unless the event has been registered and received approval from the state veterinarian 30 days prior to the event. **Swine exhibition report required.** The sponsor of the swine exhibition shall electronically submit to the department the approved report form within five business days after the conclusion of the exhibition. The form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian: the date that the exhibition occurred; the name, address and telephone number of the premises from which the swine was moved after the exhibition if such premises is a different premises.

SHEEP AND GOATS

All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag. (Ex. IA1234-5678) or another official Scrapie tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag (Ex. IA1234-5678) another official Scrapie tag or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824). Wethers less than 18 months of age are required to have an individual identification and a scrapie tag may be used, but a scrapie tag is not required.

POULTRY AND BIRDS

All poultry exhibited must come from U.S. Pullorum-Typhoid clean or equivalent flocks or have had a negative Pullorum-Typhoid test within 90 days of public exhibition and the test must have been performed by an authorized tester. (SEE GENERAL SECTION 1.B) **Please note: Poultry purchased from a hatchery and raised for exhibition are not exempt from Pullorum-Typhoid testing requirements.** However, "Market Classes" of poultry consigned to a slaughter establishment are exempt from the Salmonella testing requirements. "Market Classes" of poultry must be separated from all other poultry by a distance of ten or more feet and/or an eight foot high solid partition.

DOGS AND CATS

All dogs and cats exhibited must have a current rabies vaccination certificate.

FARM DEER

Accredited veterinarians must be approved to administer tuberculosis tests on Cervidae. "Cervidae" means all animals belonging to the cervidae family and "CWD susceptible cervidae" means whitetail deer, blacktail deer, mule deer, red deer, elk and moose. Native Iowa Cervidae may be exhibited without other testing requirements when accompanied by a Certificate of Veterinary Inspection that lists individual official identification.

All Cervidae must have been part of the herd of origin for a least one year or were natural additions or must have originated from a chronic wasting disease monitored or certified herd in

which these animals have been kept for a least one year or were natural additions. Cervidae originating from a herd with a diagnosis, signs, epidemiological evidence or area under quarantine for chronic wasting disease may not be exhibited. The following statement must appear on the Certificate of Veterinary Inspection: "All Cervidae on the certificate have been part of the herd of origin for at least one year or were natural additions to this herd. There has been no diagnosis, signs or epidemiological evidence of chronic wasting disease in this herd for the past year."

THE DECISION OF THE OFFICIAL SHOW VETERINARIAN WILL BE FINAL.

IOWA YOUTH CODE OF ETHICS

Youth are expected to be sincere, honest and act in sportsmanlike ways at all times. Youth represent the entire program and their behavior reflects on their parents, leaders, club and the entire youth program. All adults involved with the youth program, leaders as well as parents, are expected to set positive examples and serve as positive role models by what they say and do. Any youth who breaks the code of ethics or allows another person (adult or peer) to talk them into violating the code of ethics agrees to forfeit all prizes, awards and premiums. The youth may also be prohibited from exhibiting at this and future exhibitions including the Iowa State Fair and other county, state or regional exhibitions. Youth agree to follow these guidelines:

- I will do my own work, appropriate for my age and physical and mental development. This includes research and writing of exhibit explanations, preparing exhibits (such as sewing, cooking, refinishing, etc.), care and grooming of animals, etc. Adult assistance should help guide and support me, not do it for me.
- 2. All exhibits will be a true representation of my work. Any attempt to take credit for other's work, alter the conformation of animals, or alter their performance is prohibited (see #7). Copyright violation or allowing others to complete your exhibit is considered misrepresentation and is prohibited.
- 3. I will treat all people and animals with respect. I will provide appropriate care for animals.
- 4. I will present exhibits that are safe for consumption. All food exhibits will be safe to exhibit and for judges to evaluate. Other exhibits will be safe for judges to evaluate and for exhibition.
- 5. All food animals that may be harvested immediately following the show shall be safe for consumers, and shall have met all withdrawal times for all medications, and be free of violative drug residue.
- 6. If any animal require medical treatment while at the fair or exhibition, only a licensed veterinarian may administer the treatment. All medications that are administered shall be done according to the label instructions of the medication used

- 7. My animal's appearance or performance shall not be altered by any means, including medications, external applications and surgical procedures unless deemed medically necessary to insure safety of exhibitor, spectators and animal. Approval by the fairboard or division superintendent will be required prior to any procedures. Any animal that is found to have changed its appearance or its performance shall be disqualified from the show, and have penalties assessed against the exhibitor, parent and/or guardian by the management of the fair or exhibition. This does not include normal exhibition fitting and grooming.
- 8. I will follow all ownership and possession rules and, if requested, will provide the necessary documentation.
- 9. I will follow all livestock health requirements for this fair or exhibition, according to the state health requirements as printed in the premium book of the fair or exhibition. I will provide animal health certificates from a licensed veterinarian upon request from the management of the fair or exhibition.
- 10. By my entering an animal in this fair or exhibition, I am giving consent to the management of the fair or exhibition to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. If the laboratory report on the analysis of any sample indicates a presence of forbidden drugs, this shall be evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the exhibitor, parent and/or guardian to prove otherwise.
- 11. I am responsible for my exhibit and I will not allow others to violate this code on my behalf. By my entering an exhibit in this fair or exhibition I will accept any disciplinary action taken by the management of this fair or exhibition for any violation of the code of ethics and any other rules of competition of the fair or exhibition without recourse against the fair or exhibition.
- 12. I want my exhibit to be an example of how to accept what life has to offer, both good and not so good, and how to live with and learn from the outcome.
- 13. I will not be involved in any illegal activities while participating in 4-H and FFA events, including but not limited to alcohol, tobacco or drug use.

I agree to conduct myself in an honest, ethical and upstanding manner and I understand that disciplinary actions will result if these rules are violated. I understand that I am expected to represent the program in a positive manner. I have read, understand and agree to follow this code of ethics and any other rules of competition of the fair or exhibition as printed in its premium book.

By entering & exhibiting at the Poweshiek County 4H/FFA Fair you are agreeing to abide by all rules and regulations including the Iowa Code of Ethics.

ANY VIOLATION OF RULES WILL BE HANDLED BY THE FAIRBOARD AND DIVISION SUPERINTENDENTS.

SUPERINTENDENTS ARE TO REPORT RULE VIOLATIONS AND OTHER ISSUES DIRECTLY TO FAIRBOARD DIRECTORS.

All Livestock Class Entry Forms must be obtained on line at poweshiekcountyfair.org

ONLY FORMS PROVIDED BY THE FAIR OFFICE AND AVAILABLE ONLINE WILL BE ACCEPTED. NO PHONE ENTRIES ACCEPTED

Animals and livestock will not be required to have a health check or health paper prior to coming to the fair. Animals will be evaluated for any potentially infectious issues at check in by the species superintendent. (see Swine check in procedure) If the superintendent has any questions or concerns regarding the health of an animal they will request that that animal be temporarily confined until the animal can be checked by the official fair veterinarian. Grinnell Veterinary Clinic serves as the fair veterinarian(s) and will have one of their veterinarians come to the fairgrounds at no charge to make the final decision as to whether or not the animal is safe to be around other animals. Refer to each division for specific check in procedures. If all rules are not followed by an exhibitor and/or parent(s), at the sole discretion of the fairboard the exhibitor could be banned from showing at one or more Poweshiek County 4-H/FFA Fairs. Second offenses by the exhibitor and/or parent(s) will result in lifetime suspension of the exhibitor from the Poweshiek County Fair.

The fairboard will not require swine to have a designated ID day however swine must be identified and verified by 4-Her online. FFA exhibitors will submit their ID forms to the fair office at the fairgrounds. Livestock must be identified the same year it is exhibited. Livestock must be identified for Poweshiek County to be eligible to exhibit in Poweshiek County. ALL

 Livestock exhibits are to be owned, housed & fed by the 4-H or FFA exhibitor from time of ID/entry deadline to time of sale. Jan 15 for beef & May 15 of current year for all others. Check each division for date & time of identification day(s). If exhibitor is not the owner a contract arrangement must be made between exhibitor and owner of the animal. A copy of this contract arrangement must be sent to the fair board by July 1st of current year in order for exhibitor to show the animal. The contract is to state who the owner is, who the exhibitor is, beginning date of care and that the exhibitor is doing 90% of the animal care.
- 3. Any breed not listed in the fairbook specifically will be shown in commercial class.
- 4. Decisions as to whether an animal is placed in purebred or grade class will be left to the superintendents and will be made on an individual basis at the fair.
- 5. Livestock must be shown and sold through the fair sale by the owner unless excused by the division superintendent and 1 fairboard director. If excused, another 4-H/FFA member from the county will be permitted to show or sale for him/her. See livestock department rule # 2 for exceptions.
- 6. **BACK CARDS:** Exhibitors must wear back cards with their assigned exhibitor number while showing their animals in the livestock classes. Any current Poweshiek County 4H or FFA member assisting another exhibitor showing in any livestock class must wear a back card with the number of the owner of the animal(s). Example: Jane Doe is showing her 3 pigs in the pen of 3 class. Anyone helping Jane show must wear Jane's exhibitor number also. Extra back cards are available at the livestock office. **Pick up extra back cards prior to the beginning of the show to prevent delays and confusion during the show. Those assisting another 4H/FFA member may clip the owners show # over their own number while assisting with showing.**
- 7. Exhibitors of purebred animals must present a pedigree to the department superintendent upon arrival at the grounds and the paper must be furnished to the judge if called for.

- 8. All animals unloaded at the grounds must be exhibited in the ring otherwise no premiums will be given in that division and will not be eligible to be sold through the fair sale ring. Each animal must be entered and shown in at least one class or be | removed from the grounds immediately.
- 9. NO ONE WILL BE ALLOWED IN THE RING EXCEPT PERSONS AUTHORIZED BY THE FAIR OFFICIALS.
- 10. **All livestock are to be delivered to the fairgrounds clean!** Wash rack priority will be: Friday Horses, Saturday Sheep, Meat & Dairy Goats Sunday Beef & Bottle Calves Monday Swine. Animals are not to be fed in the wash racks or surrounding area.
- 11. Exhibitors are expected to obey the officials promptly in producing their livestock when instructed to do so. Any person refusing shall be ruled out of competition. Division superintendents WILL NOT go looking for exhibitors who are not in the ring when the class is ready to begin.
- 12. Any person knowingly misrepresenting age, breeding, etc. of stock or any person who shall attempt to interfere with the judge while in discharge of his or her duty or who shall on the premises of the Poweshiek County Fair Association use any disrespectful language in respect to the decisions or awards shall thereby be excluded from the fair for one or more years thereafter.
- 13. Any artificial means of removing or remedying physical defects or conformation in animals exhibited such as lifting or filling under the skin or filling of animals with a force pump will be considered as fraud and deception. All animals giving evidence of such treatment will be barred from exhibition at this fair and will be reported to the Iowa State Fair. Fair officials must be permitted to examine animal(s) upon request.
- 14. Livestock exhibitors will be required to supply feed and bedding (see Beef & Bottle Calf departments for bedding exceptions). Only one bale of bedding on the aisle for each pen. Stalls and pens must be cleaned and manure hauled away each day. Animals are not to be fed in barn aisles. They are to be fed only in their stall or pen. Exhibitors are required to clean out their stalls, pens, cages, under cages etc. at the conclusion of the fair. ATTENTION HORSE EXHIBITORS A HORSE SUPERINTENDENT MUST CHECK OUT HORSE DEPARTMENT EXHIBITORS BEFORE LEAVING THE FAIRGROUNDS AT THE END OF THE FAIR. Those not complying forfeit their premium(s) in that division. Manure shall be deposited at west ends of barns only. Woodchips/shavings are to be used. No Straw. Woodchips/shavings will be available for purchase at the fair.
- 15. No extra stalls will be supplied to any club or person for any reason until all exhibits are in place. Exhibitors will receive stall/pen space needed for animals brought to the fair. Extra stall/pen space will be divided among clubs, not individuals. All grooming chutes will be left out of the barns unless room permits. Stall cards will be posted by division superintendents and ARE NOT to be moved without superintendent's permission.
- SHOWRING AND PROJECT SALE DRESS CODE: See Poweshiek County Fair General Information section.
- 17. PROJECT SALE: Each exhibitor is allowed two (2) sales per division. Exhibitors must inform each division superintendent (immediately following the conclusion of judging) of the number of animals they will be selling. The final deadline for reporting is Sunday at 6:00 p.m. See Swine rule # 13 for sale information. If exhibitors miss the deadline they WILL NOT be allowed to sell the project/livestock that was not reported on time. Projects/livestock must be sold by the owner unless excused by the division superintendent & 1 fairboard director. If excused, another 4-H/FFA member from the county will be permitted to take the project/livestock into the sale ring. Dress code is to be followed for the project sale. Back card numbers are not required.

- 18. Animals must be delivered in the same condition as when sold.
- Any project offered for sale in an auction is considered to have changed 19. ownership even if bought back by the original owner or if the owner refuses a bid or says, 'no sale'. All projects/animals offered for sale are terminated as 4-H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. This ruling comes from the state 4H and FFA rules.
- Steers having the permanent central incisor teeth up in wear are not eligible. 20. Such animals are considered as having reached an age beyond that which is consistent with the intent and purpose of this show.
- All fans used for cooling must meet safety standards. Superintendents' 21. discretion will prevail. No butt fans allowed on the fairgrounds.
- YQCA training is required for beef, dairy, meat goat, poultry, rabbit, 22. sheep and swine exhibitors at the County Fair. Contact the Poweshiek Co. Extension Office for YQCA information. FFA exhibitors contact your advisor.
- Any animal shown or entered in any other county 4-H or FFA Fair CANNOT 23. shown at the Poweshiek County 4-H/FFA Fair as a 4-H or FFA project. ALL VIOLATERS WILL BE DISQUALIFIED.

Protest, Discipline or Complaint Policy

Any and all shall have 24 hours from the conclusion of the show involving the class in question, to file any protest, challenges of disciplinary action or complaints brought under the provisions of this premium book. The fairboard will not consider any protests, challenge of disciplinary action or complaints based upon the statement that a judge or judges are incompetent. Any and all protest, challenges of disciplinary actions or complaints shall be filed in writing and accompanied with a \$50.00 cash deposit of which will be forfeited if the protest is not sustained. Deposit must be filed with the fairboard president contemporaneously with any and all protests, challenges of disciplinary actions or complaints. Any and all may appeal any decisions of the fairboard concerning any protests, challenges of disciplinary action or complaints brought forth. Any and all shall have 24 hours from the entrance of a decision to appeal and shall be accompanied by a non-refundable \$100.00 cash deposit.

HERDSMANSHIP

The following guidelines will be used for judging each club's herdsmanship skills:

- 1. Cleanliness of Alleys and Pens 60 points
 - a. Bedding adequate, bright, dry, clean and in place.
 - b. Animals securely tied and/or penned.
 - c. Manure hauled out and deposited in proper place.
 - d. Alleys swept clean, free of dust and woodchips.
- 2. **Arrangement of Exhibit 10 points**
 - a. Show boxes out of alleys and in a straight line.
- b. Hay and woodchips neat and orderly.
 - c. Feed boxes and miscellaneous gear stored out of sight, if possible.
- 3. Appearance of Animals 30 points
 - a. Animals are clean and brushed.

Judging will be by separate animal divisions. There will be a club winner in each animal division. Herdsmanship is the responsibility of the exhibitor(s). Judging will take place Thursday thru Monday. Divisions will not be judged on show day. A \$10.00 award will be given to each club/chapter winner in each division. A single club/chapter may win in more than one division. No attendant will be required but is encouraged. Herdsmanship awards will be given at 5:15 p.m. on Monday in the show ring. Please have a representative present.

LIVESTOCK JUDGING CONTEST & SKILL-A-THON

The livestock-judging contest will take place on Friday, July 16th at 10 a.m.

- 1. All 4-H & FFA members are eligible to enter.
- 2. Each club is eligible to enter a junior team and a senior team. Junior teams will consist of members' grades 4-8 (completed). Senior teams will consist of members' grades 9-12 & FFA to age 21. The top three scores for each team will form the team score.
- 3. Recognition will be given to the top individual and team in each classification. (Junior & Senior teams).
- 4. Plaques and cash will be awarded in the contest.

SHOWMANSHIP

Junior and Senior

- 1. Junior Showman under 14 years of age as of the day of the show.
- 2. Senior Showman -14 years of age & over as of the day of the show.
- 3. Each showman must show his/her own project.
- 4. Previous winners in showmanship are not eligible to participate in the same age division.
- 5. Members are expected to groom their own animals.

6. Exhibitors must enter & exhibit in at least one class to be eligible for showmanship.

Class entered & exhibited in must be in the same division as showmanship entered.

Winners Showmanship: A Junior winner may advance to Senior level regardless of age. Once an exhibitor is no longer eligible to participate in the Senior level they may participate in Winners Showmanship for the remainder of their years exhibiting at the Poweshiek County Fair.

An exhibitor may not participate in more than one showmanship class per year. Example: A junior winner cannot participate in senior showmanship the same year they win junior.

- 3. No health papers required, however all cattle must be free of warts, ringworm or any other contagious and/or infectious conditions; animals will be inspected by official fair vet at superintendent's discretion.
- 4. Each exhibitor is responsible for his/her own cattle at all times during the fair.
- 5. Superintendent's ask that exhibitors contact them with any scratches by the Sunday prior to the fair starting. Bedding fees will be refunded. Submit refund request to the fair office.
- 6. Tack stall will be **PROVIDED** depending upon **AVAILABLE SPACE. NO SHOWBOXES IN AISLES PLEASE**

- 7. Judging will be based on exhibitor's knowledge of the animal, how exhibitor handles the calf, the cleanliness and neatness of the calf and the relationship between exhibitor and calf. The judging will be broken down into conference judging (worksheets/interview) and final judging. Conference judging between exhibitor and judges will occur on Saturday July 10th in the Exhibit Building. Exhibitors will need to turn in 3 copies of their completed bottle calf worksheets prior to this date. (Please watch the 4H newsletter for deadlines). These worksheets will need to be brought to the Extension Office in Montezuma. The exhibitors will be scheduled for a specific time to complete their conference judging.

If the exhibitor has a conflict with the assigned time, please contact a superintendent to re-schedule. If the exhibitor does not attend the conference judging and has not been excused by the fairboard & superintendent zero points will be given for both the conference and worksheet. If exhibitor has an acceptable excused absence (eg. School trip) and submits a completed bottle calf worksheet points will be awarded for the report but zero points for the conference. Please submit your excused absence in writing to the fairboard and a copy to the superintendent. Final judging will be in the show ring on Sunday July 18th withthe exhibitor and calf together.

- 8. 80% of the exhibitors score will be based on the conference judging which includes oral conference & bottle calf worksheet. The remaining 20% will be based on the final judging which includes the condition of the calf. Bottle calf exhibitors will not be judged on showmanship.

Dog Obedience

- 1. Entries in this division are open to purebred or mixed breed dogs and may or may not be owned by the exhibitor. But the dog is to have been trained, cared for and managed by exhibitor.
- 2. Exhibitor may have more than one entry in an obedience class.

Class

- 101 Intro Class: This class is for first year exhibitor with first year dog only. Dogs must not have earned any obedience title through AKC, UKC etc. Dogs must be able to do the following exercises: heel, figure 8 sit for exam, all on leash; recall on leash (no finish). Long sit (1 minute) and long down (1 minute) on leash.
- 102 Beginners Novice A: This class is only for dog and handler teams in their 2nd year of training. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Rally Novice level signs will be used for this class. Novice A course will be used.
- 113 Rally Intermediate For dogs which have competed in any rally class and are in their 3rd year of Rally training or more, or for a dog who has earned any Rally Novice title (AKC, UKC etc.). All exercises are performed on leash. There will be between 12-17 stations (start and finish not included) with a minimum of three and a maximum of seven stationary exercises. Intermediate courses will have a minimum of three advanced level stations. There are no jumps in this class. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise.

The purpose of the youth dog program is to promote sportsmanship, demonstrate teamwork, develop and enhance a working relationship between dog/handler teams and to provide and promote an environment of positive, motivational and reinforcing training methods.

- To enroll in agility, a dog-handler team must have completed an obedience class. Dog-handler teams that have earned an agility title in any AKC, USDAA, NADACvenue may enroll in advanced agility.
- 2. Dog-handler teams wishing to participate in agility must also participate & compete in one obedience or rally class.
- 3. Each dog-handler team must start at the Novice level of agility.
- 4. If the dog is not owned by the exhibitor or immediate family member see rule # 2 under Livestock Department Rules. Dog superintendent, Extension Representative and training instructors should be made aware of this arrangement.
- 5. Agility is a course consisting of various obstacles with 3 levels of competition, each increasing in difficulty. Each dog/handler team must begin at the first level prior to Progressing.
- 6. For the safety of the dogs they must be a minimum of 12 months old for agility competition. Younger dogs may attend agility training classes but will not be allowed to compete until 12 months old.
- 7. No dog with any physical or mental condition that would impair performance will be allowed to compete in agility. Some examples include hip dysplasia, obesity, slipped stifles or advancing age. (continued on next page)

A judge and/or county instructor will have the authority to stop participation of any dog whose soundness they question. Exhibitors are strongly encouraged to contact their veterinarian if they question their dog's ability to participate.

- 8. Dogs who exhibit aggression toward other dogs or people will not be tolerated and will not be allowed to participate in the dog project.

- 2. Please read general rules, departmental rules and health rules.
- 3. Mare or gelding of any age may be shown. Age as of January 1.
- 4. Each exhibitor is eligible to show one entry per class except in halter. More than one exhibit per exhibitor will be allowed in the halter classes.
- DRESS CODE: blue jeans, English/western boots, a solid white or colored, button 5. or snap front, long sleeved, collared shirt is required. The following is prohibited: personalized logo, embroidery (excluding shirt brand logo), zippers, sheer or lace fabric, embellishments, bling of any kind including but not limited to sequins, rhinestones, chains etc. Shirts must be tucked in. A necktie, kerchief or bolo tie are permitted but not required. 4-H or FFA patch or armband, English/western hats or helmets for halter classes and safety helmets for all other classes. ATTENTION SWINE EXHIBITIORS – CHECK IN PROCEDURE

Due to new regulations by the Iowa Department of Agriculture and Land Stewardship regarding unloading of swine at a county fair the Poweshiek County Fairboard has implemented a new swine check in procedure. The State of Iowa Veterinarian is requiring that all swine be inspected before being unloaded at the fairgrounds.

The following procedure will be required for exhibiting swine at the 2021 Poweshiek County

4H/FFA Fair:

Swine will be checked on the trailer or truck by the official fair veterinarian before being unloaded at the fairgrounds on Wednesday, July 14th from 6-8 a.m.

ATTENTION: Weigh in will be held on Wednesday July 14th 6 – 9 a.m.

All swine must go through this check in procedure or they will not be eligible to be shown.

No pigs are to be unloaded until they have been checked by the fair veterinarian.

After inspection pigs may be unloaded and stalled in the barn.

Due to how congested things get behind the barns with livestock coming in Wednesday afternoon and Thursday morning the fairboard felt this was the best procedure to follow. This will allow for plenty of room for trailers and trucks to line up for inspection.

Any exhibitor that does not follow this check in procedure will not be allowed to exhibit swine at the fair.

No other animals will be allowed on the fairgrounds during swine check-in. Beginning arrival time for all other livestock is Wednesday at 4 pm.

If you have any questions please contact swine superintendent Ryan Iverson at 641 325-1174 or the Poweshiek County Fair Office.

WEIGH IN SCHEDULE: Wednesday July 14th 6-9 a.m. 4H/FFA member or family member must be present when their swine is weighed. Every exhibitor must complete a "class check-in card" and return it to swine committee as soon as pigs are weighed.

Please contact the Extension Office or FFA Advisor for Iowa State Fair pig identification requirements.

- 1. All market pigs will be ear tagged with a county 4-H ear tag and EAR NOTCHED by the National Ear Notching System.
- 2. The fairboard will not require swine to have a designated ID day however swine must be identified and verified by 4-Her online. FFA exhibitors will submit their ID forms to the fair office at the fairgrounds. The fair office will send a copy to the Extension Office. All purebreds must be farrowed after January 1st.
 ONLINE VERIFICATION REQUIRED at 4Honline.com by May 15.
 Only pigs that match the original identification will be allowed to show at the Poweshiek County Fair. IF A PIG LOOSES A TAG BEFORE THE FAIR IT MUST BE REPLACED. NO PIGS WILL BE ALLOWED THAT DO NOT HAVE A 4-H EAR TAG IN THEIR EAR WHEN THEY ARRIVE AT THE FAIR. THIS NEW EAR TAG MUST BE RECORDED ON THE ID FORM AT THE EXTENSION OFFICE. TO HAVE TAGS REPLACED CONTACT THE EXTENSION OFFICE. Please notify the fair office of any tag replacements.
- 3. ALL EXHIBITORS MUST BE YQCA CERTIFIED. CONTACT THE EXTENSION OFFICE FOR DETAILS.
- 4. **HEALTH REQUIREMENTS** <u>No health papers required.</u> No testing for pseudorabies required. However, each exhibitor must sign and turn in an owner affidavit that states animals being exhibited did not originate from a quarantined herd and to the best of their knowledge, swine dysentery has not been in evidence in their herd for the past 12 months. Affidavits are available from the swine superintendents and are to be turned in with weigh-in cards.

- 5. Each exhibitor may enter and show a maximum of 8 pigs. The following are the maximum swine entries each exhibitor can show at the fair:
 - i. 6 market hogs (purebred & crossbred but no more than 4 of one type)
 - ii. 4 breeding gilts (purebred & crossbred but not more than 2 of one type)
 - iii. 1 pen of 3 comprised of any swine the exhibitor brought to the fair
 - iv. Market hogs will be shown in the following divisions:
 - 1. Crossbred market barrows
 - 2. Crossbred market gilts
 - 3. Purebred market barrows
 - 4. Purebred market gilts
 - a. Depending on the number of purebred animals shown, gilts & barrows may be combined into one class of multiple breeds.
 To qualify for a breed class-3 purebred market animals must be exhibited.
 - v. Breeding gilts will be shown in the following divisions:
 - 1. Crossbred breeding gilts
 - 2. Purebred breeding gilts
 - a. Depending on the number of purebred animals shown, breeds may be combined. To qualify for a breed class, 3 purebred breeding gilts must be exhibited.
 - vi. Gilts can only be shown as a market pig or breeding gilt, not both.
 - vii. All purebred animals must have the original registration paper checked in when the animal is weighed. The registration paper must be in the exhibitor's name or in partnership. All purebred breeding gilts must follow breed association guidelines and requirements for exhibition.
- 7. Individual market pigs and pens of 3 in each weight class will be placed in blue, red or white award groups according to type, finish and market desirability, corresponding to market hog grades of US #1, #2, #3.
- 8. 1st and 2nd place market barrows and gilts, pens of 3 and breeding gilts will be selected in each weight class. In the individual market classes, only 1st and 2nd place pigs from classes weighing between 225# and 310# will be eligible to show for Champion and Reserve Champion. Pens of 3 and breeding gilts, all class winners are eligible for Champion and Reserve Champion. Champion and Reserve market barrows and gilts will compete for Grand Champion and Reserve Grand Champion Market Pig
- 9. Superintendents reserve the right to split classes at any weight and decide sale order of livestock.
- 10. All swine will be weighed for classification on Thursday, July 18th. Official fair scale weight will be used with no re-weighs. Pigs will be sold on this weight.
- 11. All swine are to be delivered to the swine barn clean.

- 12. All swine exhibitors must complete the swine sale card & return it to the swine committee no later than 30 minutes following the swine show if they wish to sell any hogs in the sale or send them to market via the designated buyer. Any exhibitor sending pigs to a commercial packer either directly or through the fair sale will be required to sign an affidavit provided by the packer stating their pigs have never been fed Paylean.
 - i. Each exhibitor may keep 2 pigs to go through the fair sale ring.
 - ii. Each exhibitor can sell any pigs to the designated buyer permitting each animal weighs more than 225 lbs.
 - iii. Each exhibitor can take any of their swine back home, but they must stay at the fair until release time.
- 13. Due to limitations of the packers, the fairboard will not provide a market for any swine weighing less than 225 lbs and will not be allowed to go through the sale.
- 14. Each exhibitor will be given a "check in" card. You are required to fill out and return the card to a designated person as soon as pigs are weighed. DO NOT LEAVE THE SWINE BARN WITH OUT TURNING IN YOUR CARD!
- 16. All swine exhibited at the Poweshiek County Fair must NOT have hair clipped shorter than ½ inch in length on any portion of the body. The only areas exempted and allowed to have hair shorter than ½ inch are the head and legs of the animal. Any swine in question will be checked and disqualified if body hair is less than a ½ inch in length. Why? Our current buyer will no longer accept swine with body hair less than a ½ inch in length. If you are concerned about length, our suggestion is to not clip your animal or make sure you are using a 5/8 inch guard on your clippers.

Clover Kids Section Grades K-3

Goals and Philosophies of the Clover Kid program:

- 1. To give an opportunity to participate in activities uniquely suited to the developmental age
- 2. To grow and learn in a non-competitive environment
- 3. To participate in hands—on learning in a cooperative environment
- 4. To teach life skills appropriate for youth in Kindergarten through Third grade

Youth must meet the following guidelines to participate in the Poweshiek County Fair:

- 1. Youth must be in Kindergarten through Third grade during the 2020 2021 school year.
- 2. Youth must be enrolled as a Clover Kid in a Poweshiek County Clover Kid Club by May 15th.

Clover Kid Classes/Shows for the Poweshiek County Fair:

Indoor Displays- (Clover Kids are limited to three indoor projects. (Crafts, baked goods, posters, sewing, home improvement, horticulture, etc.)

Display exhibits in 4-H Exhibit Building (Check in Saturday, July 10th starting at 9:00 am) – Clover Kids have the opportunity to bring projects and speak with an adult volunteer about their indoor project. All projects receive a participation ribbon and will be kept on display until July 19th at 10 a.m. Projects must be removed by 8 pm on the 19th.

- 1) They will be given a Clover Kid entry tag for each project at check in.
- 2) A Clover Kid goal card will need to be attached to the exhibit. (This information is available on the extension website: http://www.extension.iastate.edu/poweshiek/ or the Poweshiek County Fair website: www.poweshiekcountyfair.org)

Clover Kid Small Pets – (Limit of one pet) (Clover Kids will interview with an adult volunteer. All projects receive a participation ribbon. Interviews will be held Saturday, July 10th from 10:00 to 11:00 am.

- 1) A Clover Kid pet goal card will need to be brought with the pet. (This information http://www.extension.iastate.edu/poweshiek/ or the Poweshiek County Fair website: www.poweshiekcountyfair.org)
- 2) Check the Health Requirements as stated in the section of the Pet Department of the fair book. These will apply for Clover Kid pet projects.
- 3) Bring a picture of your pet if you would like to display it in your club's booth during the fair.

Clover Kids Livestock Show ALL CLOVER KIDS LIVESTOCK WILL SHOW ON SUNDAY, JULY 18TH. SEE FAIR SCHEDULE FOR TIMES.

Clover Kids will only be allowed to house their animals at the fair if space permits. This will be determined after the June 15th class entry deadline.

General Rules

- 1. Youth must be an active Clover Kid in Poweshiek County
- 2. Eligible animals: Rabbits, Bucket/Bottle Calf, Lamb, Cavy, Poultry or Goat. Specifically excluded animas are swine, equine, camelids (Llama/Alpaca), beef (other than bucket/bottle) and dairy (other than bucket/bottle). **Assisting with these animals during exhibition in the show ring is not allowed.**
- 3. Entries due by June 15th at the fair office.
- 4. One entry per species.
- 5. Interview questions are noted in #11 and exhibitors need to be prepared to answer with judge on the day of the show
- 6. Bucket/Bottle animals must be born in year of the show
- 7. If an animal will be housed at the fair they must follow all health requirements and check in procedures required for 4H/FFA exhibitors. A \$2 bedding fee will be charged for bucket/bottle calves. Bucket/bottle animals must be brought in by Wednesday, July 14th. Check in with Extension staff Cathy Lents, Ashtin Walker or Tammy Sutfin.
- 8. If animal is not being housed at fair, animals need to be brought to the fair the day of the show (information of details will be given to exhibitors that pertain to their species before fair)
- 9. The bottle calves are to be shown with a halter: lambs/kids should be shown with a halter
- 10. Each Exhibitor will be responsible for identifying his/her own rabbit if they should get loose at the fair.
- 11. During conference judging, the exhibitor will be asked to attempt the following:
 - 1. Showmanship:

The animal needs to be clean and neat

The exhibitor can handle the animal with some assistance from the adult if needed (Looking for a relationship between exhibitor and project)

Keep the animal between themselves and the judge

2 Interview

Where did you keep your animal?

What did you feed your animal?

What was the best part of raising your animal?

What was the worst part of raising your animal?

- 12. Participation ribbons will be given for this class. No premiums will be paid.
- 13. Exhibitors are to wear a 4-H Clover Kid/4-H Club t-shirt in the show ring.
- 14. Animals are released after conference judging.
- 15. Stall cards will be put up by bottle calf superintendent and are not to be removed without superintendent permission.
- 16. Bottle Calves shown as a Clover Kid project may not return as a second year bottle calf when the Clover Kid joins 4H.
