# Poweshiek County Youth Bucket of Junk Contest

Completed entries are to be brought to the fairgrounds Exhibit Building on Tuesday, July 16<sup>th</sup> between 4 & 6 pm. Please return the empty bucket for use during next year's contest.

The finished products can be auctioned during the Project Sale/Auction at the Poweshiek County Fair on Sunday, July 21<sup>st</sup> at 6:00 pm or can be taken home starting at 1 pm on Sunday, July 21st. If selling sign up on the form located on the wall at the south end of the Exhibit

Building by 8 pm Saturday, July 20<sup>th</sup>. Proceeds from the sale of the project will go to the exhibitor.

**Dog Policy:** Dogs are only allowed in the campgrounds during fair week unless they are being shown or they are a service animal. Dogs are not to be in or around buildings, show ring, arena, parking lots etc. This policy is for the safety of the public, exhibitors and livestock.

Fair Camping: All returning campers must have their completed reservation form and fee of \$125 into the fair office by May 15. The camping fee will reserve the spot you were assigned last year for those who camped at the Poweshiek Co. Fair. ATTENTION: Late registrations for returning campers will no longer be allowed. If you do not submit your camping registration form and \$125 fee by May 15<sup>th</sup> your camping spot will be reassigned. Those returning campers who miss the renewal deadline may ask to be placed on the new camper waiting list at the fair office. The order of the list will be determined by a first entry received basis. Those on the waiting list will be notified of available spots ASAP after May 15<sup>th</sup>. ELECTRICITY WILL BE AVAILABLE WHEN CAMPERS ARRIVE.

- 1. Electrical plug ends must be 10-3 cord or heavier. Anything less will be unplugged.
- 2. Each camping unit is allowed 1-40 Amp & 1-110 electrical hookup.
- 3. The campground opens for fair camping on Sunday, July 14<sup>th</sup>, 6 a.m. NO EARLY CAMPERS ALLOWED. WEST SIDE, BACK ROW CAMPERS MUST ARRIVE BETWEEN 6 A.M. & NOON ON SUNDAY. IF YOU ARE UNABLE TO PARK YOUR CAMPER DURING THIS TIME CONTACT THE CAMPING SUPERINTENDENT. West side front row campers may start arriving at noon on Sunday July 14<sup>th</sup>. East side & north end campers may start arriving at 6 am on July 14<sup>th</sup>. All campers must be in place by Tuesday, July 16<sup>th</sup> at 6:00 pm to secure camping spot.
- 4. Tents will be charged \$25.00. All individual tents NOT set-up in a designated camping spot must be placed in the designated tent area.

- 5. All electrical camping spots will be charged **\$125.00**, whether or not they are hooked up to electricity.
- 6. One camping unit per plug in.
- 7. PCFA will not be responsible for electrical malfunctions that result in damage to campers or equipment.
- 8. PCFA will not be liable for theft or damage of any article caused by fire or any act of God.
- 9. No minors under 18 years of age will be allowed to camp without adult supervision.
- 11. Campers in non-electric spots will be charged \$25.00.
- 12. If you bring your dog with you while camping at the fair they are to stay in the campgrounds. Dogs are not to be in or around buildings, show ring, arena, parking lots etc. during fair week. Only dogs being shown, participating in the animal costume contest or service animals will be allowed out of the campground.
  - This policy is for the safety of the public, exhibitors and livestock.
- 13. Campers will be limited to 2 vehicles per camping spot. Please park your extra vehicles in the parking lot east of the Exhibit Building. This will alleviate the overcrowding in the camping area making it possible for everyone to come and go as needed.

Returning campers send \$125.00 with <u>completed reservation form</u> to: PCFA Camping, P.O. Box 372, Grinnell, IA 50112 by **May 15.** 

New campers once notified of an opening will have 7 days to submit their registration form and fee.

Camping reservation form and fee may also be dropped off at the fair office using the drop box (located by the office door) after regular office hours.

**Fair Premiums:** The fairboard will pay premiums to individual exhibitors by September 30th. In the event that the fair association has insufficient funds to pay the full premiums (with a cap of \$30 per member), the board of directors shall pro-rate all premiums. **Checks will be void after 90 days of issue date.** 

**Dress Code:** To create uniformity and eliminate confusion the Poweshiek County Fairboard has established the following dress code for exhibiting at the Poweshiek County Fair with the exception of horse exhibitors who have a set dress code.

**Shirts** – All exhibitors in conference judging, show ring/livestock judging and project sale are expected to wear a logoed shirt of any color that represents the organization the member is exhibiting under. Official Iowa State Fair t-shirts are also acceptable. Any shirt with inappropriate wording or graphics will not be allowed. See Communications Event Day attire for exceptions. Club t-shirts and patches may be purchased through club leaders. See your FFA chapter advisor for FFA shirts. Clover Kids (k-3<sup>rd</sup> grade) will wear their club t-shirt

**Apparel** – **No shorts allowed.** Conference judging exhibitors are required to wear dark jeans or dark skirt (jean skirt acceptable). Show ring/livestock judging and project sale exhibitors are required to wear blue jeans.

No holes or tears allowed in jeans or jean skirt.

**Footwear** – Closed toe shoes are required for all livestock shows. Static judging does not require closed toe foot wear.

**Ball caps or hats -** Not allowed while exhibiting or participating in the project/livestock sale.

Exhibitors in violation of the dress code will forfeit all premium money in each division the dress code is not followed. Exhibitors violating the dress code for the project sale will forfeit premiums in the division that they are selling projects/livestock. In certain cases exhibitors may forfeit all premium money.

**Project Sale:** Any livestock or non-livestock project that has been judged and exhibited at the current fair may be sold through the project sale on Sunday, July 21st. All non-livestock projects will be sold at the beginning of the sale. Exhibitors may ONLY have a total of two (2) sales for non-livestock projects. Projects/livestock must be sold by the owner unless excused by the division superintendent & 1 fairboard director. If excused, another member from the county will be permitted to take the project/livestock into the sale ring. Dress code is to be followed for the project/livestock sale. **All projects must be signed-up to sell by 8:00 p.m. Saturday, July 20th or they will not be eligible to sell.** NO EXCUSES! NO EXCEPTIONS! Exhibitors selling non-livestock projects need to sign up

on the poster near the south wall of the exhibit area. All animals selling in the project/livestock auction can be signed up on one (1) card per exhibitor. Project sale livestock sign up cards will be available at the livestock office located in the NW corner of the covered show ring. Complete your card and return it to the livestock office. There will be a sample card posted by the livestock office to use as a guide. The card is for livestock only. If you have questions about the new card please contact the fair office or a department superintendent.

**Iowa State Fair selection of conference judged exhibits:** The exhibit building will be closed to the public when conference judging is done. This will allow the judges to make Iowa State Fair exhibit selections.

REMEMBER! NO LIVESTOCK CLASS ENTRY FORMS WILL BE ACCEPTED AFTER JULY 1. NO EXCEPTIONS OR EXCUSES! ALL LIVESTOCK PROJECTS MUST TURN IN A CLASS ENTRY FORM EVEN IF THEY WERE SHOWN THE YEAR BEFORE. NO OVER THE PHONE ENTRIES ACCEPTED. ONLY LIVESTOCK CLASS ENTRY FORMS OBTAINED AT POWESHIEKCOUNTYFAIR.ORG WILL BE ACCEPTED. If submitting form by mail it is recommended that you email or call the fair office to verify it was received. An online entry option at poweshiekcountyfair.org will be available May 1, 2024. Paper entry forms will still be accepted in 2024. Clover Kids will submit paper forms.

It is the responsibility of the exhibitor to read and understand the rules in each division. If there is a question, please ask your division superintendent, Poweshiek County Fair Office, club leader, FFA advisor, or Extension Office.

**Bedding:** Exhibitors are required to furnish their own bedding. Bagged bedding will be available on a cash only basis — no charging. Wood chips/shavings only. No straw allowed. **See Beef department, Bottle Calf department & Clover Kids Section for bulk bedding requirements.** 

Read all instructions and rules for every department.

All Clubs & Chapters will be notified of pre fair clean-up dates and times. All members are expected to attend at least one designated clean-up day.

**Fair Booth Set Up:** Wednesday July  $10^{th} - 4$  to 7 pm The Exhibit Building will be open during this time for booth set up and decoration. NOTICE: Only painters tape may be used to secure items to the floor of the Exhibit Building. Duck tape, masking tape etc. is not allowed. Nothing is to be attached to the walls or on the acoustic panels. It is the responsibility of the club members and leaders to disassemble and return entire project display (tables, back drops etc.) to the proper storage place at the conclusion of the fair. All trash and debris must be placed in trash cans.

The theme for the 2024 Poweshiek County Fair is: **Let the Fair Times Roll!** – Submitted by the 4 Bar H 4-H Club.

This theme may be used for all aspects of the county fair including stall and barn decorations.



Parade of Grand Champions & Iowa State Fair Project Selections will take place on Sunday, July 21st at noon in the covered show ring. Exhibitors who received a Grand Champion livestock award (including the dog division) and/or had a project selected to go to the Iowa State Fair will be recognized. Exhibitors may choose to parade their animal, and/or their ISF project OR they may parade just their banner and/or ISF rosette only. Exhibitors are not required to participate in the parade however all eligible exhibitors will be recognized even if they don't participate. A parade order will be posted Sunday morning. Exhibitors are to line up in this order. For questions please call the fair office at 641 236-7959 or email powfair@iowatelecom.net

#### PREMIER EXHIBITOR AWARD

The Premier Exhibitor award was developed to encourage and award exhibitors with a diverse fair experience by entering multiple divisions and departments. In an effort to level the playing field for all exhibitors, indoor departments & outdoor divisions the following rules are applied:

- 1. No entry form needed.
- 2. FFA and 4-H exhibitors are eligible to qualify.
- 3. Only premium-eligible classes qualify for points.
- 4. Event Day entries are excluded.
- 5. Points are awarded as follows:

Purple – 4 Points

Blue - 3 Points

Red - 2 Points

White - 1 Point

Disqualified - 0 Points

- 6. No points for Grand, Reserve Grand, and Showmanship awards.
- 7. Cash payout will be for the top three exhibitors.
- 8. The total number of points awarded for ribbons by Division/Department is capped at 15.
- 9. In the event of a tie, the following criteria will be used to determine the winner:
  - a. Total number of premium-eligible entries using the same eligibility as rules 1-6 with no cap by division/department.
  - b. In the event that there is still a tie after 8.a., total accumulation of points for all premium-eligible entries using the same eligibility as rules 1-6 with no cap by division/department.

c. In the event that there is still a tie after 8.b., a name will be drawn at random to determine a winner.

Joe's Photography entries earned 16 points but is capped at 15 points. Joe earned 3 points for his blue ribbon in the Beef division. Joe has 18 points.

John received a blue ribbon and a red ribbon in different departments and divisions. John has 5 points.

Jane earned four purple ribbons from four different divisions and departments for a total of 16 points. Jane also received a blue ribbon in the Sheep division. Since Jane has not exceeded the maximum of 15 points in the Sheep division, she was awarded the 3 points for the blue ribbon. Jane has 19 points.

# **Exhibit Building Host and Hostess Guidelines & Schedule**

- 1. In the Exhibit Building, host and hostesses are needed to greet guests, guard displays and answer questions throughout the week of the fair.
- 2. Clubs are encouraged to provide a make-it-take-it craft for their scheduled time. .
- 3. Each shift will be 2 hours in length. Each club should have 2 people with 1 being an adult present during the club's entire assigned time. (feel free to ask grandparents, adult siblings etc. to help out)
- 4. If you are representing your club, please report at the scheduled time.
- 5. Please remember you are representing your club. Please follow the established dress code.
- 6. NO food is allowed in the exhibit area! Please remember this and do not bring food or drinks with you during your scheduled time.
- 7. Clubs are allowed to switch times with other clubs if an assigned time is not convenient, but remember there must be hosts present in the building during the assigned times.

#### GENERAL RULES FOR ALL EXHIBITS & EXHIBITORS

If all rules are not followed by exhibitor and/or parent(s) at the sole discretion of the fairboard, exhibitor will receive written notice that they could be banned from showing at one or more Poweshiek County Fairs.

By entering and exhibiting at the Poweshiek County Fair you are agreeing to abide by all rules and regulations including the Exhibitor Youth Code of Ethics.

#### EXHIBITOR YOUTH CODE OF ETHICS

Youth are expected to be sincere, honest and act in sportsmanlike ways at all times. Youth represent the entire program and their behavior reflects on their parents, leaders, club and the entire youth program. All adults involved with the youth program, leaders as well as parents, are expected to set positive examples and serve as positive role models by what they say and do. Any youth who breaks the code of ethics or allows another person (adult or peer) to talk them into violating the code of ethics agrees to forfeit all prizes, awards and premiums. The youth may also be prohibited from exhibiting at this and future exhibitions including the Iowa State Fair and other county, state or regional exhibitions. Youth agree to follow these guidelines:

1. I will do my own work, appropriate for my age and physical and mental development. This includes research and writing of exhibit explanations, preparing exhibits (such as sewing, cooking, refinishing,

- etc.), care and grooming of animals, etc. Adult assistance should help guide and support me, not do it for me.
- 2. All exhibits will be a true representation of my work. Any attempt to take credit for other's work, alter the conformation of animals, or alter their performance is prohibited (see #7). Copyright violation or allowing others to complete your exhibit is considered misrepresentation and is prohibited.
- 3. I will treat all people and animals with respect. I will provide appropriate care for animals.
- 4. I will present exhibits that are safe for consumption. All food exhibits will be safe to exhibit and for judges to evaluate. Other exhibits will be safe for judges to evaluate and for exhibition.
- 5. All food animals that may be harvested immediately following the show shall be safe for consumers, and shall have met all withdrawal times for all medications, and be free of violative drug residue.
- 6. If any animal require medical treatment while at the fair or exhibition, only a licensed veterinarian may administer the treatment. All medications that are administered shall be done according to the label instructions of the medication used.
- 7. My animal's appearance or performance shall not be altered by any means, including medications, external applications and surgical procedures unless deemed medically necessary to insure safety of exhibitor, spectators and animal. Approval by the fairboard or division superintendent will be required prior to any procedures. Any animal that is found to have changed its appearance or its

performance shall be disqualified from the show, and have penalties assessed against the exhibitor, parent and/or guardian by the management of the fair or exhibition. **This does not include normal exhibition fitting and grooming.** 

- 8. I will follow all ownership and possession rules and, if requested, will provide the necessary documentation.
- 9. I will follow all livestock health requirements for this fair or exhibition, according to the state health requirements as printed in the premium book of the fair or exhibition. I will provide animal health certificates from a licensed veterinarian upon request from the management of the fair or exhibition.
- 10. By my entering an animal in this fair or exhibition, I am giving consent to the management of the fair or exhibition to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. If the laboratory report on the analysis of any sample

indicates a presence of forbidden drugs, this shall be evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample tested by the laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the exhibitor, parent and/or guardian to prove otherwise.

- 11. I am responsible for my exhibit and I will not allow others to violate this code on my behalf. By my entering an exhibit in this fair or exhibition I will accept any disciplinary action taken by the management of this fair or exhibition for any violation of the code of ethics and any other rules of competition of the fair or exhibition without recourse against the fair or exhibition.
- 12. I want my exhibit to be an example of how to accept what life has to offer, both good and not so good, and how to live with and learn from the outcome.
- 13. I will not be involved in any illegal activities while participating in Poweshiek County Fair events, including but not limited to alcohol, tobacco or drug use.

I agree to conduct myself in an honest, ethical and upstanding manner and I understand that disciplinary actions will result if these rules are violated. I understand that I am expected to represent the program in a positive manner. I have read, understand and agree to follow this code of ethics and any other rules of competition of the fair or exhibition as printed in its premium book.

By entering & exhibiting at the Poweshiek County Fair you are agreeing to abide by all rules and regulations including the Exhibitor Code of Ethics.

ANY VIOLATION OF RULES WILL BE HANDLED BY THE FAIRBOARD AND DIVISION SUPERINTENDENTS. DIVISION SUPERINTENDENTS ARE TO REPORT RULE VIOLATIONS AND OTHER ISSUES DIRECTLY TO FAIRBOARD DIRECTORS.

#### GENERAL RULES FOR ALL EXHIBITS & EXHIBITIORS

(continued)

- 1. Admission to all exhibits, lectures and demonstrations is free.
- 2. The fairboard reserves the final and absolute right to interpret all rules and regulations. This includes the ability to arbitrarily settle and determine all matters, questions, and differences connected with or incident to the fair.
- 3. Care will be taken to secure the safety of stock and exhibits but the fair association will not be responsible for any loss or damage that may occur.
- 4. The fair board reserves the right to reject for cause any exhibit.
- 5. All classes will be placed in blue, red or white groups unless it is a non-premium/non ribbon class. A project awarded a blue ribbon is considered above average, red ribbon is average and white ribbon is a little below average. The judge's ribbon placing is FINAL. If you have any questions, please contact the fair office.
- 6. Classes are open to current members of Poweshiek County 4-H clubs or a FFA chapter who are in good standing with their respective organizations. Associate (younger then 4<sup>th</sup> grade) members are not eligible to exhibit at the fair unless they are a member of Clover Kids. Clover Kids cannot assist with any 4-H or FFA livestock exhibits in the show ring. However, they may exhibit in the non-livestock Open Class.
- 7. IMPORTANT! All livestock class entry forms must be turned in to the fair office in Grinnell by June 15. Entries may be sent by mail or dropped off. Do not send or drop off entries at the Extension Office. Each entry submitted to the fair office after June 15 will be charged a \$5.00 late fee per division. ATTENTION: Absolutely NO livestock class entries will be accepted after July 1. NO EXCUSES!! Only livestock class entry forms obtained at poweshiekcountyfair.org will be accepted. No over the phone entries. See page 8 for online entry option.
- 8. Superintendents must be at least 19 years of age and a non-exhibitor at the Poweshiek County Fair. Superintendents will have complete charge of their respective divisions, including stall and exhibit arrangements. However, this does NOT include changing or bending rules and regulations! Superintendents do not have the authority to make the decision as to an exhibitors eligibility to show. A minimum of 3 fairboard directors must be informed of any issue that may result in an exhibitor not being eligible. Superintendents will report rule violations & other issues directly to fairboard directors.

- 9. All exhibits must comply with the rules set by this fairbook in order to show.
- 10. All livestock will be in the barns on the fairgrounds until 3 pm Sunday, July 21st. All non-livestock exhibits are to be in place on the fairgrounds until 1 p.m. Sunday, July21st. Any exhibitor removing livestock or other exhibits before release time, without the consent of the fairboard, will forfeit ALL awards and premiums received on each project removed.
- 11. No alcoholic beverages will be allowed on the fairgrounds during the county fair. Any members/exhibitors involved with alcoholic beverages will be evicted from the fairgrounds and all awards including plaques, ribbons and premiums will be withheld. No project will be accepted for an exhibit if an alcoholic beverage or container has been used in any part of the exhibit.
- 12. 4-H members may exhibit at the Poweshiek County Fair until the year of high school graduation or age 19. Exhibitors may continue to exhibit at the Poweshiek County Fair to the age of 21 as active FFA members. All rules and regulations apply. Please contact the fair office for clarification. Exhibitors show per grade level completed and/or age: Junior grades 4-6, Intermediate grades 7 & 8, Senior grades 9-12/FFA to age 21.
- 13. Profanity is not to be used by exhibitors at any time.
- 14. Anyone owing money to the Poweshiek County Fair Association from the previous fair(s) must make payment in full before being allowed to buy woodchips or camp at the current fair.
- 15. Anyone that has been suspended from exhibiting at the Iowa State Fair will be suspended from showing at the Poweshiek County Fair.
- 16. No one is allowed in the barns between midnight and 5:00 AM except superintendents, security personnel and fair board directors.
- 17. **NOTICE:** Any project offered for sale in an auction is considered to have changed ownership even if bought back by the original owner or if the owner refuses a bid or says, "no sale". All projects/animals offered for sale are terminated as 4H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. This ruling comes from the state 4-H and FFA rules
- 18. Youth for the Quality Care of Animals/YQCA training is required for beef, dairy, meat goat, poultry, rabbit, sheep and swine exhibitors at the County Fair. Contact the Poweshiek Co. Extension Office or FFA Advisor for information on YQCA. Completion deadline is July 1<sup>st</sup>.

**Awards and Sponsors:** The name and address of award sponsor is on each plaque, banner and envelope. Please send the sponsor a thank you note.

# **Conference Judging Rules**

- 1. Please note general, departmental and division rules.
- 2. Dress Code: See pages 19 & 20.
- 3. Clubs will be designated a time to bring all exhibits including Ag Dept. Horticulture Class 10230 and County Fair Horticulture Class exhibits on Saturday, July 13<sup>th</sup>. Exhibits will be judged in conference with the judge and member at the designated time. Leaders and members are encouraged to be present for the judging, other interested persons and members are welcome. Judging will begin at 9 a.m.
- 4. Exhibits will be evaluated with consideration given for the knowledge and abilities of the exhibitor as shown in conference with the judge. Parents, grandparents etc. are welcome to sit in on the conference with the judge but are not to participate.
- 5. There are no limits on the number of exhibits that may be brought to the fair except in class 10320 photography. The limit of 6 photography projects per exhibitor remains and will be enforced.
- 6. Each item in an exhibit must be securely labeled with the exhibitor's name, exhibitor's club, and class number. Labels should be placed on the back of posters and cards, and in an inconspicuous place on other items. A completed Poweshiek County Fair entry tag should be securely fastened to the main item in each exhibit in an easily seen location.
- 7. Blue, red or white ribbons will be awarded to exhibitors on the basis of conference judging. Outstanding exhibits will be awarded purple ribbons and state fair exhibits will be awarded purple rosettes. Yellow ribbons denote those exhibits strongly considered for state fair.
- 8. The judge's decision is FINAL.

- 9. 4-H members who have completed 5th grade through 12th grade (or that equivalent) in 2024 are eligible to exhibit at the Iowa State Fair. Exception: Group exhibits from an entire club may include 4th grade members.
- 10. No Entry fee is required.
- 11. Exhibits that do not comply with the class description, size guidelines, copyright restrictions, safety, and approved methods will be disqualified and not put on public display.
- 12. Following the county fair, all exhibits that are chosen to go to the Iowa State Fair must be taken home by the exhibitor. **NO STATE FAIR EXHIBITS WILL BE LEFT AT THE FAIRGROUNDS**. Exhibitors will be responsible for getting their exhibits to the Extension Office following the county fair. Check with the Extension Office for the deadline for bringing in your projects.
- 13. Exhibit classes are broad categories. To plan exhibits, exhibitors are encouraged to use "Exhibit Tip Sheets", project guides and program materials. "Exhibit Tip Sheets" are located on the state 4-H website <a href="http://www.extension.iastate.edu/4h/projects">http://www.extension.iastate.edu/4h/projects</a> or they may be obtained from your leader. Each "Exhibit Tip Sheet" allows for exploration of a project by providing information, resources and exhibit ideas. An exhibit can represent a part or all of the learning involved in the respective project.
- 1) Each exhibitor is required to complete a written explanation for each exhibit, questions are listed below. A form is available at the Extension Office. Members using video or cassette tapes as a part of their county fair exhibits should make arrangements with the Extension Office ahead of time to have equipment available or may bring their own equipment. Exhibitors should respond briefly to the following questions about the exhibit:
  - a) What did you plan to learn or do?
  - b) What steps did you take to learn or do this?
  - c) What were the most important things you learned as you worked toward your goal(s)?
  - d) What would you like to do in this project area next year?
  - e) If your exhibit is a **Visual Art, Home Improvement, or**Clothing exhibit the following needs to be completed: **Please**identify the design elements/art principles used in the exhibit

- **and how they are used.** Check the Poweshiek County Fairbook for requirements.
- f) Copyright logos, designs, or trademark materials should not be used for exhibits on public display at a fair or other setting without written permission. If written permission has been obtained for an exhibit, it should be submitted with the exhibit. See fairbook rule #19.
- g) General Financial Summary
- h) Example of Exhibit Record for projects can be found following the Elements and Principals of Design
   NOTE: Check for additional requirements in exhibit classes for clothing and fashion, home improvement, 4-H poster communication food and nutrition, photography, and visual arts classes.
- 14. Exhibits with a goal that better fits a different department/class will be moved to that department/class, at the discretion of the superintendent/Iowa State Fair Rules and Regulations.
- 15. Eligible exhibits are an outgrowth of work done as a planned part of the 4-H'ers participation in 4-H projects or programs during the current 4-H year. Exhibits can be done by an individual or group and may represent all or part of the learning in the project or program. Exhibits might be, but are not limited to an actual product, poster, display box, report, notebook, model, videotape, audiocassette, etc.
- 16. The 4-Her's goal and applicable exhibit standards will form the basis of the evaluation process. Evaluation criteria will include demonstrated learning, workmanship, techniques, general appearance and design. Exhibitors will receive written evaluation comments on the exhibits and a blue, red or white exhibitor's ribbon. Refer to exhibit class evaluation tip sheets for detailed evaluation criteria in each class. Tip sheets are located on each 4-H project page at <a href="https://www.extension.iastate.edu/4h/exhibit-tip-sheets">https://www.extension.iastate.edu/4h/exhibit-tip-sheets</a>
- 17. If the exhibitor chooses a display to illustrate what was learned:
  - Posters may not exceed 24" x 36" in size. (See Classes 10490 and 10530 for smaller requirements.)

- Chart boards, graph boards, project presentation boards, model displays, etc., may not exceed 48" x 48" in size. Maximum size is determined by measuring the flat (unfolded) dimensions.
- Display boxes may not exceed 28" x 22" in height or width and 12" in depth.
- 18. Endangered and threatened plants and animals (including insects), or songbird feathers and nests may NOT be used in any exhibit. Wildflowers taken from parks should NOT be used. It is illegal to possess songbird feathers or nests. Game animals "legally taken", such as pheasant, goose, duck, or quail, are acceptable.
- 19. Copyrighted materials and designs may not be used in an exhibit that is presented as original work by the exhibitor. Exhibitors must include permission from the copyright holder/owner when using copyrighted materials. Exhibitors must give proper credit to the original source of all materials/designs used in the exhibit. (See also special rules for Visual Arts and general copyright information for 4-H members).
- 20. All outdoor exhibits which includes but not limited to projects with gas motors or are too large to enter the Exhibit Building MUST be taken home after conference judging. They may be brought back to the fair by 8 a.m. opening day of the fair for display. If exhibitor chooses to not bring the project back to the fair a 5x7 photo of the project must be displayed in the club booth.
- 21. All exhibits, activities and programs must represent appropriate safety procedures in the development of the exhibit and during the evaluation process. This includes static exhibits and activities revolving around the communications program.
- 22. **NOTICE:** Any project offered for sale in an auction is considered to have changed ownership even if bought back by the original owner or if the owner refuses a bid or says "no sale". All projects/animals offered for sale are terminated as 4-H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. THIS RULING COMES FROM THE STATE 4H AND FFA RULES.

23. Exhibitors in 4-H classes are not eligible to exhibit in a similar department of the FFA divisions or vice-versa. See also "4-H Department General Rules & Regulations". Exhibits previously entered in an FFA Ag Science Fair or any other FFA event or competition may not be entered in any 4-H exhibit class.

24. STATE FAIR: All exhibitors are responsible to read and comply with the Iowa State Fair General Rules for the exhibit to be eligible for Iowa State Fair exhibition. Exhibits which do not comply with size guidelines, copyright, and safety procedures will not be accepted for entry, evaluation, or display at the Iowa State Fair.

## **COUNTY EVENT DAY - June 8, 2024**

### **COMMUNICATION DEPARTMENT**

Purpose: The Communication Event Program provides opportunities for 4-H youth to develop their personal communication skills by sharing talents, knowledge, or information with others.

Communications forms are available from the Extension Office. Check upcoming 4-H newsletters for more entry & entry fee information. Certificates will be presented at the end of judging day. Plaques and other community recognition will be presented at the Community Awards during county fair. Premiums will be paid by the fairboard in the Communications Department.

## **General Communication Event Program Rules and Regulations**

 4-H members who have completed 5th grade through 12th grade (or that equivalent) in 2024 are eligible to participate at the Iowa State Fair. Exception: Share-The-Fun and Extemporaneous Speaking - See event rules for age guidelines.

- 2. Educational Presentations and Working Exhibits may be given by one or more 4-H members Teams consisting of youth of mixed grades will be subject to the time limits based on the grade of the member in the highest grade level (i.e. a team with a 5th grader and an 8th grader will use the times for the intermediate/senior class).
- 3. Topics selected by the 4-H member(s) should be an outgrowth of their 4-H experience(s). Topics should be appropriate for presentation to a general audience.
- 4. Educational Presentation, Working Exhibit, and Extemporaneous Speaking participants cannot be involved in another event (communication event, clothing programs, livestock show or judging) during the half-day they are scheduled to participate in their communication event. Share-The-Fun participants cannot be involved in another event from 30 minutes prior to the beginning of the schedule show to 15 minutes following the show. Participation in multiple activities may not always be possible because of schedule conflicts.
- 5. All participants are required to attend the scheduled orientation session prior to participating in their event. (Times subject to change.)
  - Educational Presentations: 8:30 a.m. or 1:00 p.m. (August 8 -17)
  - Working Exhibits: 8:30 a.m. or 1:00 p.m. (August 8-17)
  - Share-The-Fun: 20 minutes prior to the show, normally Noon and 5:00 p.m. times may vary (August 8-17)
  - Extemporaneous Speaking: 8:30 a.m. or 1:00 p.m. Monday, August 12/Thursday, August 15; 8:30 a.m. Sunday, August 18
- 6. Only presenters are allowed in the Educational Presentation, Working Exhibit and Extemporaneous Speaking preparation rooms.
- 7. Educational Presentation and Working Exhibit participants will be involved in a "peer evaluation program".
- 8. All 4-H Educational Presentation, Working Exhibit, and Extemporaneous Speaking participants will receive Certificates of Recognition and written evaluation comments. Seals of Merit will be presented to those giving outstanding presentations. Seals of Excellence will be presented to those giving superior presentations. Share-The-Fun participants will receive participation ribbons and a written critique of their performance. Participants are expected to be present for awards given at the close of their event session.
- 9. Participants in the 4-H Communication Program are expected to wear appropriate clothing representative of the 4-H Youth Program and/or the topic of the presentation.

- 10. 4-H members must use sanitary and safe procedures and methods at all times. Educational Presentations and Working Exhibits involving food must follow established food safety guidelines.
- 11. All participants are expected to comply with all copyright/trademark regulations. Copyrighted material may not be distributed without permission.
- 12. Entries are selected from the County Communication Event program.
- 13. Stickers are not allowed in the 4-H Exhibits Building. Stickers may not be used in any Communication Event for any reason.
- 14. If live animals will be used as part of a Communication Event, the exhibitor must comply with the 2024 Health Requirements for the Exhibition of Livestock, Poultry and Birds at State Fair, District Shows and Exhibitions. This can be found at <a href="https://iowaagriculture.gov/animal-industry-bureau/animal-admission-health-requirements">https://iowaagriculture.gov/animal-industry-bureau/animal-admission-health-requirements</a>. Animals that do not comply will not be allowed in the 4-H Exhibits Building or on the Iowa State Fairgrounds.
- 15. Allocated premiums will be paid to counties for distribution based on the participation in the 4-H Educational Presentation, Working Exhibit, and Extemporaneous Speaking opportunities. There will be no premium allocations for Share-The-Fun.

#### **EDUCATIONAL PRESENTATION**

#### 11100 Educational Presentation

Provide an opportunity for 4-H members to demonstrate communication skills by presenting knowledge, information, or a process to an audience. Educational presentation may be given by one or more 4-H members. Participants must turn in a completed Educational Presentation Report form during event check-in.

## **Educational Presentation Rules**

1. Time limit: Junior Presentations (5th and 6th grade) must not exceed 15 minutes. Intermediate/Senior

Presentations (7th - 12th grade) must not exceed 20 minutes. Presenters will be verbally told to "STOP" when they exceed the time limit.

- 2. Participants must turn in a completed Educational Presentation Report form during event check-in.
- 3. 4-H members may participate in <u>one</u> Educational Presentation per year at the Iowa State Fair.
- 4. **Presentation content must be the original work of the presenter**(s). Extensive paraphrasing from other sources is prohibited.

Use of brief quotations or excerpts of from other work(s) is permitted provided the source is identified.

5. A judge's critique/conference with each participant will be included.

#### WORKING EXHIBIT DEPARTMENT

## 11200 Working Exhibit

Provide an opportunity for 4-H members to communicate, interact with, and teach an audience in an informal and experiential way.

## Working Exhibit Rules

- 4. Time limit: All participants/teams will be scheduled for a 30-minute period.
- 2. Participants must turn in a completed Working Exhibit Report form during event check-in.
- 3. 4-H members may participate in <u>one</u> Working Exhibit per year at the Iowa State Fair.
- 4. A judge's critique/conference with each participant will be included.

#### **SHARE-THE-FUN**

## 11300 Share-The-Fun Program

Provide an opportunity for 4-H members to share their skills and talents before an audience purely for the sake of enjoyment.

## **Share- The- Fun Rules**

1. Eligibility: 4-H members who have completed 5th grade through 12<sup>th</sup> grade (or that equivalent) in 2024 may advance to the State Fair.

**Exception**: If the Share-The-Fun act involves a <u>whole</u> club, the following criteria must be applied to determine if the club can be entered in the Share-The-Fun Program at the Iowa State Fair:

- At least 80 % of the performing group must have completed 5<sup>th</sup> through 12<sup>th</sup> grade in 2024.
- Clover Kids are not eligible to participate at the Iowa State Fair
- 2. Share-The-Fun performances must not exceed 6 minutes in length.
- 3. Skits, songs, stunts, short one-act plays, dance and other entertainment are acceptable. All performances must be appropriate for presentation to a general audience.
- 4. All acts must turn in a completed 4-H Share-The-Fun Report form at event check-in to confirm stage setup, cue music etc.

5. A judge's critique/conference with each participant will be included.

## **EXTEMPORANEOUS SPEAKING**

### 11400 Extemporaneous Speaking

Encourage the development of communication skills by providing an opportunity to think, organize thoughts, prepare a speech and response to questions when given a limited amount of preparation time.

#### **Extemporaneous Speaking Rules**

- 1. Participants must be senior 4-H members completed 9th through 12th grade (or that equivalent) in 2024.
- 2. Each county may enter a maximum of two entries; individuals may participate once per year at the Iowa State Fair.
- 3. Program format:
  - a) Thirty minutes before the speech, each participant will draw three of the available topics, selecting one to speak on.
    - The selected topic will not be available to the other participants in the speaker's assigned room. The general nature of the topics will relate to 4-H. The other two topics drawn but not chosen will be returned to the available topics for the other participants.
    - b) A preparation room is to be used with one participant per speaking site admitted initially and one additional participant per speaking site admitted each 15 minutes as the program progresses. A participant may not leave the preparation room until it is time to speak, nor may a participant receive help from a parent, leader, other adult, or any other youth.

A program official will assist participants with the time requirements.

- c) All reference material will be screened by a program official on the following basis:
  - Participant may bring their own books, magazines or newspaper clippings for reference during the thirty minutes of preparation.
  - Reference material must be printed material such as books or magazines (cannot be notes, outlines or speeches prepared by the participant or by another person for use in this program).

- Some relevant reference material will be available in the preparation room. This material will consist of historical material related to the 4-H program.
- d) Each speech shall be the result of the 4-H members own efforts using approved reference material that a participant may bring to the preparation room. No other assistance may be provided. Plain note cards will be provided for each participant in the preparation room. If notes are used, the note cards provided must be used in delivering the speech.
- e) Only notes made during the preparation period may be used.
- f) Each speech shall be not less than four but no more than six minutes with five minutes additional time allowed for related questions, which shall be asked by the judge. The participant will be shown timecards in an ascending order (1, 2, 3, 4, 5) by the timekeeper. "Stop" will be said at six minutes.
- g) The program timekeeper will introduce each participant by name and the county they represent, and read the selected question.
- h) Participants are not permitted to use any props, gadgets, posters, or audiovisuals of any sort. A podium will not be available.
- 4. Speeches will be evaluated using the following criteria:
  - a) Content related to topic.
  - b) Knowledge of the subject.
  - c) Organization of material.
  - d) Power of expression.
  - e) Voice.
  - f) Stage presence.
  - g) General effect.
  - h) Response to questions.
- 5. A judge's critique/conference with each participant will be included.

#### IOWA STATE FAIR COMMUNICATIONS JUDGING:

Exhibitors advancing to the State Fair must make arrangements through the Extension Office.

## **CLOTHING EVENT**

## Check upcoming 4-H newsletters for entry & entry fee information.

#### General Overview

- 1. Each youth may only participate in the 4-H wardrobe Clothing Event with one entry in one class per year. Participants may be selected to participate in any one of the four classes, even if they participated in that class in previous years.
  - 2. Each county may send the following number of participants in each class to represent their county, selected from each of the count's events:
    - a. **Fashion Revue Class**: Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
    - b. **\$20** Challenge Class: Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
    - c. **Clothing Selection Class**: Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
    - d. **Innovative Design Class**: Four participants total with no more than two (2) participants with an entry in any given category (athletic wear, formal wear, everyday wear, costume).
  - 3. State Fair: The categories in each class are simply for entry limit purposes. All entries in each class will be judged together.
  - 4. Participants must be in the senior 4-H designated level (completed grades 9 -12 in same year as event) in order to qualify and advance to the State Fair.
  - 5. Outfits or accessories which will be worn during the State 4-H wardrobe Clothing Event may not be entered as another 4-H Iowa State Fair exhibit.
  - 6. Participants must bring the garment or outfit they purchased or created, and accessories, to the State 4-H wardrobe Clothing Event.

- 7. Participants should submit only the materials requested for each class (report form and photo for ALL classes plus a receipt for \$20 challenge). If additional materials are sent with the entry or brought to the conference judging, they will not be considered.
- 8. Participant Report Forms must be uploaded by county staff by July 31. Participants should abide by county deadlines for submitting paperwork for entry. Report form responses may be in an alternate format or handwritten if preferred by the participant. Requests for class or group time changes will be honored as availability allows through July 31. Requests made after July 31 cannot be accommodated due to our printing deadlines.
- 9. All participants must participate in all wardrobe Clothing Event activities at the times scheduled for their county unless the 4-H member is involved in another Iowa State Fair 4-H activity at the same time with a non-flexible schedule, with pre-approval prior to July 31.

#### Class 12100 Fashion Revue (premium class)

- 1. The purpose of this category is to encourage the construction of a personal garment or outfit.
- 2. Consideration is given to fit, color, style, suitability, quality of construction, stage presentation, and required care.
- 3. Youth participants will model a garment or outfit they constructed, hand-knitted, machine-knitted, or crocheted during the current 4-H year.
- 4. A garment or outfit consists of one to three pieces such as, but not limited to, party clothes, tailored suits, vest, slacks, shirt, skirt, active sportswear and/or coats.
- 5. Blouses, shirts, and sweaters are usually considered as garments. If they are used to complete an outfit, they may be constructed or selected.
- 6. All other accessories and undergarments may be constructed or selected.

#### Class 12200 Clothing Selection (premium class)

1. The purpose of this category is to select and/or purchase an outfit that represents the 4-H member's goal or intended use for the selected outfit.

- 2. Judging is based on fit, color, style, suitability, quality and construction features, stage presentation, required care, and cost comparison.
- 3. There is no consideration in the judging on the amount spent, only in the process of recordkeeping and reflection on the cost of the individual items as a part of the process.
- 4. Outfits may be purchased at a department store, boutique, online store, sidewalk sales, retail shops or mall stores. Outfits may also be purchased at garage sales or other secondhand venues with at any price point. Outfits may be gifts, hand-me-downs, relative or friend's modern or vintage clothing, or existing personal clothing, as long as the 4-H member actually selected the item as part of this specific outfit for the stated purpose.
- 5. Home-sewn clothing that was not sewn specifically for the participant are acceptable, such as purchases from a used clothing store.
- 6. Any 4-H member may enter clothing selection. Participants must be present for judging.
- 7. All contestants must fill out a clothing selection form. Forms are available at the Extension Office.

#### Class 12300 \$20 CHALLENGE (premium class)

All participants must:

- 1. This class is designed to expand the 4-H member's shopping experience to shopping venues emphasizing recycling, reducing and reusing. Outfits must be purchased at a garage sale, consignment store, thrift store, secondhand store, or similar place.
- 2. Online venues are allowed and must be second-hand in nature. Shipping and handling are not included in the total calculations.
- 3. Traditional shopping venues may not be used, regardless of a low regular or sale price. Hand-me-downs or clothing as gifts do not qualify, but may be entered in Clothing Selection if 4-H member selected the items to meet a specific purpose/goal.
- 4. Twenty dollars is the purchase price limit including tax. However, some secondhand stores and venues do not typically charge sales tax.
- 5. Receipt(s) for every item included as a part of the calculated total must be submitted with the entry. A garage sale receipt can be a piece of paper with the name of the location such as "Jane Doe garage

- sale", date, amount paid, and signature of person selling at the garage sale. If the outfit was free at a garage sale, "free" can be listed on the report form and on the receipt. Failure to provide receipts will be reflected in the evaluation.
- 6. An outfit consists of major clothing pieces such as a shirt, sweater, jacket, pants or a dress. Shoes, undergarments and accessories are not included in the \$20 purchase price limit.
- 7. Alterations are permitted to achieve a desired look or fit.
- 8. There are no additional considerations for an outfit that cost less than \$20.
- 9. The outfit pieces should be purchased to meet the 4-H member's goal or intended use for the purchased outfit, and the 4-H member should have had an experience in choosing shopping alternatives, evaluating fit, quality and construction features, price, and cost comparison.

#### 12400 Innovative Design

- 1. The purpose of this class is to encourage creativity and out-of-the-box thinking when creating an outfit.
- 2. These designs can be theatrical costumes, cosplay, wearable technology, sustainable/upcycle fashion, accessible fashion, and/or outfits that use unconventional materials.
- 3. The outfit must be showcased as a worn garment modeled by the exhibitor or by the individual that is was designed for.
- 4. Exhibitors may make their garment entirely, or permanently alter the silhouette of pre-existing materials through some method of permanent alteration or addition.
- 5. Consideration is given to originality and innovation.

#### **Special Recognition**

All wardrobe Clothing Event participants will receive a participation ribbon presented at the public fashion show held at the Iowa State Fair.

The top five (5) entries in each class (Fashion Revue, Clothing Selection, \$20 Challenge, Innovation Design) will receive an award plaque.

Special Recognition will be presented by the Central Iowa Chapter, American Sewing Guild to two individuals who exhibit outstanding sewing skills in the Fashion Revue class.

One inspiring participant selected as one of the top five in the Innovative Design Class who has expressed an interest in furthering their education in fashion design, fashion merchandising, or interior design will be awarded a \$250 scholarship to Des Moines Area Community College's Fashion Institute.

The DMACC Fashion Institute Style Award (Style Book and \$50 gift card) is awarded to the participant who demonstrated excellence in styling their outfit.

One inspiring participant who has expressed an interest in furthering their education in textiles and clothing, hospitality management, or event management will be awarded a \$500 scholarship to the Iowa State University College of Human Sciences' Department of Apparel, Events, and Hospitality Management.

## Class 963 Food Challenge (premium class)

- 1. Any 4-H member may enter the Food Challenge. It is a county event only; no one will be advancing to another level of competition.
- Register by submitting your recipe to the Extension Office. Check
   4-H newsletter for entry information.
- 3. At the Food Challenge, the participant will prepare a recipe in 45

minutes or less. Categories are main dish, salad, side dish, dessert, snack or beverage. The judge will evaluate food safety in handling and preparation and conference judging will take place after final product presentation.

- 4. Participants do not need to talk during the food preparation.
- 5. Participants will receive blue, red or white ribbon awards.
- 6. Each participant can bring up to 3 prepared items (if they have carrot, pepper, onion and celery in the dish, they may precut the amount for 2 of the items and then cut the other two in front of the judge). Certain items may be pre- measured as well (as long as you show the judge one example of you measuring something).
- 7. If this item is to be baked, please bring a finished product for the food judge to sample.

#### Class 964 Table Setting Challenge (premium class)

- 1. Any exhibitor may enter Table Setting Challenge. This is a county only event.
- 2. 4-Her's may work alone or in a team to create a themed table setting.
- 3. Table setting should include:
  - a. menu (no food)
  - b. proper table service and glassware
  - c. themed decorations
  - d. You are encouraged to dress in accordance with your theme.
  - e. You should include the Principles and Elements of Design.
- 4. Conference judging will take place during the course of Event Day.
  - a. Present to the judge your theme and menu
  - b. Express knowledge of food, nutrition and food safety

FFA members may exhibit projects in the conference judging classes. FFA exhibits are not eligible for state fair. If FFA members wish to exhibit at the state fair, they will need to contact their advisor.

Exhibitors should move from project area to project area when finished in one area.

Please be sure to read General Conference Rules. All entries are required to answer the three goals questions to be eligible for state fair.

Please be sure to pick up a number card when you arrive to your judging area and wait until your number has been called for judging.

## Please be patient until your turn arrives.

Pet judging will be from 9:00 a.m. to 11:00 A.M. only (Clover Kids will have their pets judged during this time).

Horticulture will be from 9:00 a.m. to Noon. If you have Horticulture projects, you will need to come at this time regardless of when your club is scheduled.

Judges will be given a lunch break from 12:00 – 12:30p.m.

## **Class Descriptions**

Most exhibit classes have specific guidelines and requirements that will be included in the judging process. Members are highly encouraged to go to <a href="https://www.extension.iastate.edu/4h/exhibit-tip-sheets">www.extension.iastate.edu/4h/exhibit-tip-sheets</a> for information about judging criteria for exhibits that they create from their 4-H project learning.

## **ANIMALS**

#### 10110 Animal Science

An exhibit (other than the animal itself) that shows learning about a large or small animal including beef, dairy cattle, dairy goats, dogs, horse & pony, meat goats, pets, poultry, rabbits, sheep and swine. Ownership of an animal is not required.

#### 10120 Veterinary Science

An exhibit that shows learning about keeping animals healthy, animal diseases, animal/human health interaction, or other learning related to Veterinary Science.

## AGRICULTURE AND NATURAL RESOURCES

#### 10210 Crop Production & Plant Science

An exhibit that shows learning about the growth, use, and value of field crops, plant growth, soils and soil fertility, or any other learning related to crop production and plant science.

## 10220 Conservation, Environment, and Sustainability

An exhibit that shows the connections between humans and their environment including energy, stewardship, conservation, entomology, fish and wildlife, creating habitat, or forestry. Includes collections.

## 10222 Entomology

An exhibit that shows learning from an entomology or bee project (excluding live specimens) that is an outgrowth or an entomology or bee project learning experience. Includes specimen collections and may include products (ex: honey) or equipment as part of the display.

#### 10224 Fish and Wildlife

An exhibit that shows learning about a fish and/or wildlife project or program such as identification, habitats, harvest, taxidermy, etc. Any specimens must have been legally taken and must include information about date and location of harvest, and who the

specimen was acquired from if not self-harvested. Feral pigs (including Russian/European Boar) are NOT permitted in taxidermy exhibits.

#### 10226 Forestry

An exhibit, including collections, that show learning from participation in a forestry project or program.

#### 10230 Horticulture and Plant Science

An exhibit that shows learning about the growth, use and value of plants, soils small fruit production, vegetable and flower gardens, plant nutrition, careers etc. (Garden crops and herbs are exhibited in classes in the 4-H Horticulture Department under 4-H Livestock at the State Fair) State Fair Horticulture - Entries must be made with the County Extension Office by July 1. Contact the Extension Office for more information. Vegetables should be prepared and displayed according to 4-H 462, "Harvesting and Preparing Vegetables for Exhibit".

#### **10235 Home Grounds Improvement**

An exhibit that shows learning about landscape plans, selection of landscape plants, ornamental garden features, home yard improvement, storage sheds, careers etc.

#### 10240 Outdoor Adventures

An exhibit that shows learning about backpacking, biking, camping, canoeing, fishing, hiking or other outdoor activities.

## **10250 Safety and Education in Shooting Sports**

An exhibit that shows learning about safe and responsible use of firearms and archery equipment or wildlife management. (The exhibit may not include actual firearms, archery equipment allowed if tips are removed from arrows)

## **10260 Other Agriculture and Natural Resources**

An exhibit that shows learning about agriculture or natural resources and does not fit in any of the other classes listed above.

## **CREATIVE ARTS**

#### **10310 Music**

An exhibit that shows learning about musical performance, composition and arrangements, instruments, musical styles or history. If submitting a video or musical arrangement, it must be uploaded to You Tube.

## 10320 Photography – <u>Limit of 6 in this class</u>

An exhibit, either photo(s) or an educational display that shows learning about photography from choosing a camera to modifying your photo. Still photos only, not video.

## **Photography Special Rules:**

- 1. Photographs may be either black and white or color. Photographs must have been taken since your county fair of the previous year.
- 2. Photographs should be a minimum of 5" x 7" Finished size (including mounting/matting) of single photographs may not exceed 11" x 14". Exception: Panoramic photos must not exceed 11 inches high by 24" in length.
- 3. All photographs must be printed on photographic paper and must be mounded and/or matted. Maximum thickness of finished project must not exceed ½ inch thick
- 4. All photographs MUST be mounted and/or matted.
- 5. Mounted photos can be (a) flush-mounted [no board showing] on mounting board, or (b) with mount borders [window mat or flat mount directly on board]. Exhibitors may cut their own mounting boards, use ready-cut window mats or have matting done professionally.
  - 4-H members are responsible for design decisions such as border, color and size. **Framed photographs (including floating frames) will not be judged.**
- 6. A series is a group of photographs [3 to 5] that are related or tell a step-by-step story. Photographs must be mounted together and numbered in story order or sequence. Finished size of individual

- photographs in a series must be a minimum of 5 inches by 7 inches and should not exceed 6 inches by 8 inches.
- 7. Edited photos should include a copy of the photo before edits.
- 8. Subject matter of photographs must be in good taste and be appropriate for public display in a 4-H setting.
- 9. Photographs depicting unsafe practices or illegal activities will not be displayed.
- 10. Iowa State Fair 4-H photography exhibitors must use the Photo Exhibit Label to provide required information for photo exhibits. Photo labels are available at the Extension Office.
- 11. Exhibitors entered in 4-H Photography are not eligible to exhibit in the FFA Photography show and vice-versa.

### **10340** Creative Photography

A photographic image that was creatively edited or modified beyond reality in a creative, imaginative, and experimental way to make it more interesting and visually engaging. Could be a composite of multiple photographs.

## **Creative Photography Special Rules:**

- 1. Photograph/image may be mounted/matted.
- 2. If mounted, photograph/image must be mounted on foam core no smaller than 5 inches in length or larger than 14" in length.
- 3. Photograph/Image can be digitally created.
- 4. Exhibit must have the most current Photo Exhibit Label on back with required information for photo exhibits. Exhibit write- up should include additional information about the processes and decisions used to develop the exhibit.
- 5. Subject matter must be in good taste and be appropriate for public display in a 4-H setting.
- 6. Photographs depicting unsafe practices or illegal activities will not be displayed.

## 10345 Photography Idea/Educational Display

An exhibit that demonstrates learning about photography that does not fit into any previous photography class. This class may include educational

displays about printing, processing, editing, marketing, branding, merchandising, etc., as it relates to photography. Display board size may not exceed 48 inches by 48 inches.

#### 10540 Digital Storytelling

An exhibit that demonstrates the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques or other display to share what was learned. Copyright permission must be obtained for any non-original material included as part of a film/movie/video. Finished film/movie/video must be uploaded to YouTube.

10350 Visual Arts Original Art- An exhibit that shows learning through creation of original art. Original art is a one of a kind, non-replicable design of your creation. By using one medium or a combination, an individual creates an authentic work of art that is not recognizable as another's work. You must explain the application of the most relevant design element(s) and art principle(s) featured in this exhibit. Describe your inspirations, reasons, feelings, and/or motives for creating this work of art.

10355 Visual Arts -Design, Process, or Technique Exploration — This class emphasizes process and provides the opportunity to explore a medium, practice a skill, or study and apply elements and principles of art and design. An explanation of the application of design elements or art principles used when making the exhibit must be included. This exhibit may be an object, portfolio, display, poster, or organized sketchbook. If a non-original design source is used, its origin (where the idea was found, any pictures, sketches, etc.) must be credited, acknowledged or have copyright permission obtained. See visual arts special rule #5.

**10360 Visual Arts - Other Visual Art Ideas/Topics** — Exhibits might include the study and research about an individual artist, style, craft, business or marketing process, planning group tour, career options, etc.

#### **Visual Arts Special Rules:**

- 1. Items entered for exhibition at the Iowa State Fair must be ready for display in the home, gallery, or intended final display location: pictures framed, wall hangings and pictures ready to hang, etc. Make sure hangers are strong enough to support the item. Command Strips or other quick attach products are usually not adequate hangers. Items not ready for display will be dropped one ribbon placing
- 2. Exhibits made from kits or preformed molds will not be accepted. Exception: Preformed molds (greenware, whiteware) may be used to provide the appropriate surface for a process technique or application of original design.
- 3. If the exhibit is a finished art object, the source or inspiration of the design, design sketches, or other process for creating the object and design must be included. For additional information see the Visual Arts and Design Elements & Art principles Exhibit Tip Sheets at https://www.extension.iastate.edu/4h/exhibit-tip-sheets.
- 4. If the exhibit is a finished art object information must be included explaining the application of design elements and art principles used in creation of the work.
- 5. Original works of art must be a creative expression of a design unique to the artist, or represent a significant modification to an existing design to make a new and original statement by the artist.
- 6. Exhibition of derivative works created by a 4-H member is prohibited without the written permission of the original copyright holder/owner. Use of copyrighted or trademarked designs, images, logos, or materials in 4-H visual arts exhibits is prohibited unless written permission has been obtained from the copyright or trademark holder/owner. For additional information, see 4-H Exhibit Copyright Information at

## **FAMILY & CONSUMER SCIENCES**

#### **10410 Child Development**

Exhibits that include items intended for use with children. An exhibit could include careers in child development, caring for children with special needs, childcare, growth and development, or safety and health. An exhibit that includes items intended for use with children, such as babysitting kits, books, learning games, or toys, must include information about what you have learned about children while creating and using the exhibit OR what the child/children learned from their use of the item(s) in the exhibit.

## 10420 Clothing and Fashion – Constructed/Sewn Garments & Accessories

A constructed garment or accessory (sewn, knitted, crocheted or other process) that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics and/or clothing care. Exhibits must be intended to be worn by humans.

**10422** Clothing and Fashion – Purchased Garments & Accessories Purchased garments or accessories that shows learning about style, fashion, design, thrifty spending, wardrobe planning, types of fabrics and/or clothing care. Exhibits must be intended to be worn by humans.

**10424 Clothing and Fashion – Other Ideas/Educational Exhibits** Any other educational exhibit that shows learning about clothing and fashion including but not limited to design illustrations, exploration of clothing styles, careers, clothing care etc.

## **Clothing and Fashion Special Rule:**

- 1. Outfits or accessories which will be worn during the wardrobe Clothing Event may not be entered as a 4-H Iowa State Fair exhibit.
- 2. Exhibits in classes 10420 and 10422 must include information about application of design elements and art principles. Exhibits in class 10424 should include information about application of design elements and art principles if appropriate for the exhibit.

#### **10430 Consumer Management**

An exhibit that shows learning through savvy budgeting, comparison shopping, money management and consumer rights and responsibilities.

#### 10440 Food & Nutrition – Prepared Product

An exhibit of a prepared food product that shows skills or learning about cooking, baking, eating and choosing healthy foods, safety practices through the making of a prepared food product. See food and nutrition special rules below and HS 76 "Foods for Iowa 4-H Fairs Quick Reference Guide" at <a href="https://store.extension.iastate.edu/product/6434">https://store.extension.iastate.edu/product/6434</a> for additional information regarding prepared food products. Display boxes are not allowed for prepared products at the Iowa State Fair.

#### 10442 Food & Nutrition - Preserved Product

An exhibit of a preserved food product that shows skills or learning about food preservation through the making of a prepared or preserved food product. Processed honey may be exhibited in this class. See *Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs —* 

Quick Reference Guide" at

https://store.extension.iastate.edu/product/6434 for additional information regarding preserved food products.

## 10445 Food & Nutrition - Educational Display

An educational exhibit (poster, report, display) that shows skills or learning about cooking, baking, eating and choosing healthy foods, meal planning/preparation and service, safety practices, or food preservation. See *Food & Nutrition Special Rules below and HS 76 "Foods for Iowa 4-H Fairs – Quick Reference Guide" at* 

<u>https://store.extension.iastte.edu/product/6434</u> for additional information regarding prepared and preserved food products. Exhibits showing learning about meal planning and service must include a menu.

## **Food & Nutrition Special Rules:**

- 1. Any exhibit considered to be a food safety risk or portray a food safety risk will not be accepted, judged or displayed.
- 2. All food products/exhibits should be appropriate for human consumption.
- 3. Food product exhibits must be prepared, baked or cooked using only food grade utensils and containers.

- 4. Products that require refrigeration will not be accepted, judged or displayed.
- 5. Meat jerky products are prohibited.
- 6. The recipe must be included for any prepared or preserved food exhibit, including the source of the recipe.
- 7. Preserved foods must include the Food Preservation Exhibit Label. Only food processed after August 1, 2023 is acceptable. Current USDA and/or Iowa State University guidelines for home food preservation must be used. Processed honey must include the Honey Exhibit Label.
- 8. Preserved food exhibits **must** include two product samples. One will be opened for evaluation and discarded; the second will be placed on display and returned to the exhibitor. All perishable food products will be discarded when removed from display.
- 9. Prepared foods should be placed on a firm disposable plate or flat cardboard. Place food product exhibit in a reclose able plastic bag with entry tag fastened outside the bag.

Recommended number of items to include with the exhibit:

Cookies, cupcakes, bars, muffins, rolls, etc. – four (4) to six (6) items Cakes, loafs, pies, etc. – one (1) whole product.

10. The use of alcoholic beverages in the preparation or production of 4-H food exhibits is NOT permitted.

#### **10450 Health**

An exhibit that shows learning through food choices, safe activities and skills such as first aid and CPR, careers and/or healthy lifestyle choices.

10460 Home Improvement - An exhibit that shows learning in planning, improving and caring for your home living space, including extended personal living areas immediately adjacent to the home. Exhibits may include new or refinished/reclaimed/restored items. Exhibits showing learning about home design, furniture, home accessories, and fabrics must include information about how design elements and art principles were applied.

#### Home Improvement Special Rules

1. Items entered for exhibition at the Iowa State Fair must be ready for display in the home: pictures framed, wall hangings and pictures ready to hang, etc. Make sure hangers are strong enough to support the item. Command Strips or other quick attach products are usually not adequate hangers. Items not ready for display will be dropped one ribbon placing. 2. Exhibit write-up/information must include source of inspiration and/or references indicating where the idea or information was obtained, giving credit to original author(s), designer(s), artist(s).

## 10470 Sewing and Needle Arts

A constructed item (sewn, knitted, crocheted or other process) that shows learning and skill in sewing, knitting, crocheting or other needle arts. May include the construction of household items such as pillowcases, curtains, table runners, quilts, wall hangings, etc. Exhibits in this class are intended to be worn by humans.

## 10472 Sewing and Needle Arts – Other Ideas/Educational Exhibits

Any other educational exhibit that shows learning about sewing and needle arts including construction techniques, use and care of fabrics and fibers, design illustrations, decorative processes, careers, etc.

Note: Exhibits in classes 10470 and 10472 should include information about application of design elements and art principles if appropriate for the exhibit.

## 10480 Other Family and Consumer Science

An exhibit that demonstrates learning about a family and consumer science topic that does not fit any other Family & Consumer Science class listed.

## **Special Exhibition – Thrifty Meal Challenge**

**10490 - Thrifty Meal Challenge** – Create a balanced, nutritious meal for family of four (4) that includes a serving from each of the five food groups with a budget of \$11.

## Special Rules:

1. Each county may advance one (1) exhibit in this class to the state fair.

- 2. All entries will receive an evaluation and participation ribbon.
- 3. Exhibit may be from an individual or group effort.
- *4.* Total expense on receipt(s) must not exceed \$11.
- 5. The meal must serve four people with a serving for each person from each of the five (5) food groups.
  - a. Recommended portion sizes per person: ½ cup fruit, ½ cup vegetable, 3 ounce protein, 1 to 2 ounces of grain, 1 cup equivalent dairy.
  - b. If there is a dairy allergy, you may substitute it with a calcium-rich item, but you will need to indicate the allergy and identify how the item substituted provides enough calcium.
- 6. The exhibit will be a poster (maximum size 20" x 30") that includes:
  - a. A copy of the Thrifty Meal Challenge
     Worksheet attached to the back of the poster.
  - b. The menu, the outline of food items, and appropriate portion sizes for each food item.
  - c. Meal type (breakfast, lunch, or dinner)
  - d. Copy of grocery receipts (up to 2)
  - e. Photos of experience: grocery shopping, food preparation, and prepared meal.

## PERSONAL DEVELOPMENT

## 10510 Citizenship and Civic Engagement

An exhibit that shows learning about or contributing to your community, your country or your world.

#### 10520 Communication

An exhibit that shows learning about written, oral, and visual communication skills. Includes learning from participation in Theatre Arts projects or programs such as puppets, stage design, etc. May include original creative writing, poetry, fiction and non-fiction, etc. If finished exhibit includes audio or video, it must be uploaded to YouTube.

#### 10530 4-H Poster Communication Exhibit

Special poster exhibit to visually tell a story or idea visually about 4-H to the general public. Exhibitors must use one of the following themes:

- a. 4-H is... (open to 4-H members interpretation)
- b. Join 4-H
- c. I<3 4-H (2023 National 4-H Week theme)
- d. Explore the Jungle of Opportunities in 4-H (Variation 2024 Iowa 4-H Youth Conference theme)
- e. 4-H Fever (variation of 2024 Iowa State Fair theme)

### **Poster Communication Special Rules:**

- 1. Only one poster per 4-H member may be entered. Limit of two posters per county can advance to the Iowa State Fair.
- 2. All posters must be designed on, or affixed to, standard poster board or foam core board size minimum of 14" x 20" or maximum of 15"x22".
- 3. Posters may be vertical or horizontal. Posters may be any medium: watercolor, ink, crayon, acrylic, charcoal, and oils, collage, etc.
- 4. Posters <u>cannot</u> be 3 dimensional. Materials used to make the poster may <u>not</u> extend more than 1/8 inch above the poster or foam core board.
- 5. Each poster **must** have a completed Poster Exhibit Entry Form attached to the back.
- 6. Posters cannot use copyrighted material or exact copies of other promotional designs, such as the Iowa 4-H Youth Conference theme logo.
- 7. 4-H members may include the 4-H Clover in the poster.
- 8. All 4-H Communication Posters will receive Certificates of Recognition and written evaluation comments. Outstanding posters will receive Seals of Merit. Superior posters will receive Seals of Excellence.

## 10540 Digital Storytelling

An exhibit that demonstrates the application of technology to produce a creative movie/film/video. Exhibits may include a finished movie or video, creation of a detailed storyboard, editing techniques using digital video software, production techniques or other display to share what was learned. Copyright permission must be obtained for any non-original

material included as part of a film/movie/video. Finished film/movie/video must be uploaded to YouTube.

#### 10550 Leadership

An exhibit that shows learning about leadership skills and influencing others in a positive way.

#### 10560 Self Determined

An exhibit that shows learning as part of your 4-H adventure and does not fit any other class.

## **Personal Development Special Rule:**

1. Exhibits entered in the Personal Development classes should include reflection by the 4-H member stating how they personally grew or benefited from the exhibit. Why was this exhibit important to them as a person?

## SCIENCE, ENGINEERING & TECHNOLOGY

Exhibitors entered in the 4-H Science, Engineering & Technology classes may not enter in similar FFA Ag Mechanics classes and viceversa.

#### 10610 Mechanics

An exhibit that shows skills or learning about general mechanics or engineering solutions or that involve a combination of skills.

#### 10612 Automotive

Repaired or restored vehicle. (Note: vehicles will be on display at the Iowa State Fair one day only, Thursday August 8 (Tentative)).

**10613 Automotive: Educational Display** – An exhibit that shows learning about an automotive idea including automotive maintenance, auto operations, auto safety, or automotive systems

#### 10614 Electric

Constructed or repaired article or educational display that shows skills or learning about electric wiring, appliances, lighting, electrical energy sources, safety etc.

#### 10615 Small Engine

Repaired or restored operating engine or educational display or other type exhibit that shows skills or learning about small engines. This class includes repaired or restored lawn tractors, small motorcycles, go-karts etc.

#### 10616 Tractor

Repaired or restored tractor. Note: A conference judging opportunity for exhibitors of repaired or restored tractors in class 10616 will be offered during exhibit check-in. (Conference judging may not be available during all check-in times.) Tractors will be displayed outside throughout the Iowa State Fair. Release time Sunday, August 18, after 7:00 p.m.

**10617 Tractor: Educational Display** – An exhibit that shows learning related to tractors, tractor mechanics, tractor operations, or tractor safety.

## **10618 Welding**

Constructed item or educational display that shows skills or learning about welding.

## 10620 Woodworking

An exhibit that shows learning about wood, woodworking techniques and safe uses of woodworking tools and machines. Exhibits may include newly constructed or refinished/reclaimed/restored wood items.

## 10630 Science, Engineering & Technology

An exhibit that shows learning about or helps explain how science and technology help us interact with the world. Topics include, aerospace, biological and chemical sciences, computers & networking, earth & climate, geospatial mapping (GPS/GIS), or any other application of science, engineering or technology.

#### 10632 Aerospace

Educational display or other exhibit (including flyable models) showing learning about an aerospace idea or topic.

#### 10634 Robotics

Educational display or other exhibit (including working robots) that shows learning about robotics and robotic systems.

#### Science, Engineering, and Technology Special Rule:

 Exhibitors entered in the 4-H Science, Engineering, and Technology classes are not eligible in similar FFA Ag Mechanics classes and vice versa.

An example of a project is: Train engine made out of different types of candy (party favor). Let your imagination be your guide in the class and have fun with it!

## JUDGING WILL TAKE PLACE FROM 9 TO 11 A.M. TO PREVENT PETS FROM BEING CONFINED TOO LONG.

**PETS HEALTH REQUIREMENTS** – No Health certificate required – if any questions regarding pet's health, the Official Fair Vet will be called. Cats and dogs must have a rabies vaccination certificate. Poultry & birds must be tested for pullorum-typhoid **or** come from a certified clean flock. (Exhibitor must have a

certificate indicating their poultry is from a pullorum-typhoid clean flock). If you have any questions please call the fair office. Any entries not meeting the health requirements will not be judged and must be removed from the fairgrounds immediately.

- 1. Please note general and departmental rules.
- 2. All pets will be judged on Saturday, July 13th.
- 3. An educational folder or display (maximum size 22" x 28" x 18") is required with each pet exhibit.
- 4. Pet(s) must be taken home after being judged. A folder about the pet stays for exhibit.
- 5. All pets are to be clean and properly restrained (leash, pet taxi, cage, box etc).
- There are no premiums paid, ribbons or awards given. Posters will not be judged, they are for display only. Each exhibitor that brings an entry in this class to the fair will receive some type of participation recognition. Exhibits in this class are limited to posters no larger than 20" x 30". Have fun with your family looking through old Poweshiek County Fair photos. Please put captions with photos so the public can enjoy looking back also. The posters will be on display during fair week. Please bring your posters to the fair on Saturday July 8th.

## **HORTICULTURE DEPARTMENT** (not eligible for state fair)

- 1. Please note general and departmental rules.
- 2. Exhibits will be conference judged between 9:00 a.m. & noon on Saturday, July 13th.
- 3. Vegetables displayed must include on the entry tag the variety or cultivars of the species.
- 4. Exhibits must come from the exhibitor's garden.
- 5. Contact the Extension Office for information on exhibiting at the State Fair.
- 6. Exhibitors <u>must</u> take a photo of each of their Horticulture Class exhibits to be on display in the event that during fair week the project becomes unfit for public display. Photos need to be at the fair by 4 pm the Tuesday following judging.

#### Class

- Garden Basket: a collection of vegetables from exhibitor's own garden artistically arranged in a basket or appropriate container.

  Vegetables exhibited in this class are not eligible to be exhibited in Class #127.
- 127 Vegetables: One type of vegetable to a plate/tray to be prepared and displayed as recommended in publication 4H462 "Harvesting and Preparing Vegetables for Exhibit" which is available at the Extension Office. Exhibits that do not follow the recommendations as listed in 4H462 will be discounted one ribbon grouping.
- Potted Plant: Pictures showing plant growth will be required. A series of 3 pictures is recommended.
   Potted Plant (1) Terrarium (1) Flowering potted plant (1) Cactus (1) Collection of cacti in container (3 to 5) Hanging plant (1) Foliage potted plant (1) Other not listed (1)
- 130 Artistic Arrangement of Flowers: The container will be judged as part of the arrangement. Flowers exhibited in this class are not eligible to be exhibited in Class #134.
- **Small Fruit Crop:** An Educational exhibit illustrating something learned in the project. Maximum space allowed is 22" x 28" x 18".
- **Vegetable or Fruit Crop:** Vegetable or fruit raised from vegetable or fruit crop project. NOT FROM GARDEN.
- 133 Herbs: Single or collection (5). All specimens should have stems of adequate length for displaying in jars of water. Each herb species should be properly labeled.
- 134 Other Single Flower: Annual or Perennial, exhibit should include some of the plants own foliage. Exhibit should consist of either 1 spray (single stem with more than 1 bloom) or 3 blooms (1 bloom per stem) or 1 spike depending on species of flower. Example: Gladioli would require 1 spike. Marigold would require 3 blooms & Petunia would require 1 spray. Containers will not be judged. Questions? Contact the Fair Office.

## 2024 HEALTH REQUIREMENTS FOR EXHIBITION OF LIVESTOCK, POULTRY AND BIRDS AT A COUNTY 4H/FFA FAIR EXHIBITION

ANY EVIDENCE OF WARTS, RINGWORM, FOOT ROT, PINK EYE, DRAINING ABSCESSES OR ANY OTHER CONTAGIOUS OR INFECTIOUS CONDITION WILL ELIMINATE THE ANIMAL FROM THE SHOW.

No individual Certificate of Veterinary Inspection will be required on Iowa origin animals or poultry exhibited at County 4-H/FFA FAIR, but the animals must be inspected when unloaded or shortly thereafter by an accredited veterinarian. Swine are required to be inspected either before being unloaded or before leaving a designated isolation and inspection area (prior to mixing with any other pigs). All animals moving from out of state into an Iowa county 4H/FFA fair must meet Iowa Animal and Livestock Importation requirements. Each show <u>must</u> have an official veterinarian.

Quarantined animals or animals from quarantined herds cannot be exhibited.

Official identification listed on a Certificate of Veterinary Inspection required for all cattle and bison of any age **coming from out of state** used for rodeos, recreational events, shows and exhibitions.

#### **SWINE**

All swine must originate from a herd or area not under quarantine and must be individually identified. All swine are required to have individual official identification. All 4-H and FFA tags bearing the US shield are official identification tags.

**Swine originating outside of Iowa.** All exhibitors must present a test record and Certificate of Veterinary Inspection that indicate that each swine has had a negative test for pseudorabies within 30 days prior to the

show (individual show regulations may have more restrictive time restrictions), regardless of the status of the herd and show individual official identification on test report. Electronic identification will not be considered official identification for exhibition purposes.

**Swine exhibition requirements.** "Swine exhibition" means an exhibit, demonstration, show or competition involving an event on the state fairgrounds, a county fair or other exhibition event. The sponsor of the exhibition must retain an Iowa licensed veterinarian to supervise the health of the swine at the exhibition location.

The sponsor must electronically file the approved registration form and obtain approval from the state veterinarian at least 30 days before the event. The registration form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian and the date of the planned exhibition. Sales of swine will not be allowed unless the event has been registered and received approval from the state veterinarian 30 days prior to the event.

**Swine exhibition report required.** The sponsor of the swine exhibition shall electronically submit to the department the approved report form within five business days after the conclusion of the exhibition. The form includes the name of the exhibition and the address and telephone number of its location; the name, address and telephone number of the veterinarian: the date that the exhibition occurred; the name, address and telephone number of the owner of the swine; and the address and telephone number of the premises from which the swine was moved after the exhibition if such premises is a different premises.

## **SHEEP AND GOATS**

All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag. (Ex. IA1234-5678) or another official Scrapie tag. All sexually intact goats must be identified with an individual Scrapie Flock of Origin identification tag (Ex. IA1234-5678) another official Scrapie tag or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824). Wethers less than 18 months of age are required to have an individual identification and a scrapie tag may be used, but a scrapie tag is not required.

## **POULTRY AND BIRDS**

All poultry exhibited must come from U.S. Pullorum-Typhoid clean or equivalent flocks or have had a negative Pullorum-Typhoid test within

90 days of public exhibition and the test must have been performed by an authorized tester. (SEE GENERAL SECTION 1.B) **Please note: Poultry purchased from a hatchery and raised for exhibition are not exempt from Pullorum-Typhoid testing requirements.** However, "Market Classes" of poultry consigned to a slaughter establishment are exempt from the Salmonella testing requirements. "Market Classes" of poultry must be separated from all other poultry by a distance of ten or more feet and/or an eight foot high solid partition.

#### **DOGS AND CATS**

All dogs and cats exhibited must have a current rabies vaccination certificate.

#### **FARM DEER**

## Accredited veterinarians must be approved to administer tuberculosis tests on Cervidae.

"Cervidae" means all animals belonging to the cervidae family and "CWD susceptible cervidae" means whitetail deer, blacktail deer, mule deer, red deer, elk and moose. Native Iowa Cervidae may be exhibited without other testing requirements when accompanied by a Certificate of Veterinary Inspection that lists individual official identification.

All Cervidae must have been part of the herd of origin for a least one year or were natural additions or must have originated from a chronic wasting disease monitored or certified herd in which these animals have been kept for a least one year or were natural additions.

Cervidae originating from a herd with a diagnosis, signs, epidemiological evidence or area under quarantine for chronic wasting disease may not be exhibited. The following statement must appear on the Certificate of Veterinary Inspection: "All Cervidae on the certificate have been part of the herd of origin for at least one year or were natural additions to this herd. There has been no diagnosis, signs or epidemiological evidence of chronic wasting disease in this herd for the past year."

FOR SAFETY REASONS NO LIVESTOCK TRAILERS ARE TO BE PARKED BETWEEN THE WEST END OF THE BARNS AND THE DRIVEWAY.

ALL <u>NON SELLING</u> LIVESTOCK WILL BE RELEASED AT 3 PM SUNDAY JULY 21st

# Livestock class entry forms are available at poweshiekcountyfair.org.

An online entry option at poweshiekcountyfair.org will be available May 1, 2024. Paper entry forms will still be accepted in 2024. Clover Kids will submit paper forms.

#### NO PHONE ENTRIES ACCEPTED

Animals and livestock will not be required to have a health check or health paper prior to coming to the fair. Animals will be evaluated for any potentially infectious issues at check in by the species superintendent. (see Swine check in procedure) If the superintendent has any questions or concerns regarding the health of an animal they will request that that animal be temporarily confined until the animal can be checked by the official fair veterinarian. Grinnell Veterinary Clinic serves as the fair veterinarian(s) and will have one of their veterinarians come to the fairgrounds at no charge to make the final decision as to whether or not the animal is safe to be around other animals. Refer to each division for specific check in procedures.

If all rules are not followed by an exhibitor and/or parent(s), at the sole discretion of the fairboard exhibitor will receive written notice that they could be banned from showing at one or more Poweshiek County Fairs.

By entering and exhibiting at the Poweshiek County Fair you are agreeing to abide by all rules and regulations including the Exhibitor Youth Code of Ethics.

#### WOODCHIP TRAILER SCHEDULE:

WEIGH-IN SCHEDULE: Sheep - Tuesday 5-8 pm Market Goats - Tuesday 5-8 pm Beef – Wednesday 9-11 am Swine – Wednesday 6-9 am

- 1. 4-H Livestock ID'S must be done by the exhibitor at v2.4honline.com. FFA exhibitors will submit their ID forms to the fair office at the fairgrounds. NO EXCEPTIONS! Market beef, market goats & market sheep will be entered after designated county ID day but must be verified by Extension or if FFA submitted to the fair office. Market beef must be entered by February 1<sup>st</sup> all others including swine May 15<sup>th</sup> of current year. Livestock must be identified the same year it is exhibited. Livestock must be identified for Poweshiek County to be eligible to exhibit in Poweshiek County. ALL LIVESTOCK MUST BE IDENTIFIED EVERY YEAR EVEN IF IT IS A CONTINUOUS PROJECT SUCH AS 2ND YEAR BOTTLE CALF. NO ID REQUIRED FOR RABBITS OR POULTRY.
- 2. Livestock exhibits are to be owned, housed & fed by the exhibitor from time of ID/entry deadline to time of sale. Jan 15 for beef & May 15 of current year for all others. Check each division for date & time of identification day(s). If exhibitor is not the owner a contract arrangement must be made between exhibitor and owner of the animal. A copy of this contract arrangement must be sent to the fair board by July 1st of current year in order for exhibitor to show the animal. The contract is to state who the owner is, who the exhibitor is, beginning date of care and that the exhibitor is doing 90% of the animal care.
- 3. Any breed not listed in the fairbook specifically will be shown in commercial class.

- 4. Decisions as to whether an animal is placed in purebred or grade class will be left to the superintendents and will be made on an individual basis at the fair.
- 5. Livestock must be shown and sold through the fair sale by the owner unless excused by the division superintendent and 1 fairboard director. If excused, another member from the county will be permitted to show or sale for him/her. See livestock department rule # 2 for exceptions.
- 6. BACK CARDS: Exhibitors must wear back cards with their assigned exhibitor number while showing their animals in the livestock classes. Any current Poweshiek County 4-H or FFA member assisting another exhibitor showing in any livestock class must wear a back card with the number of the owner of the animal(s). Example: Jane Doe is showing her 3 pigs in the pen of 3 class. Anyone helping Jane show must wear Jane's exhibitor number also. Extra back cards are available at the livestock office. Pick up extra back cards prior to the beginning of the show to prevent delays and confusion during the show. Those assisting another exhibitor may clip the owners show # over their own number while assisting with showing.
- 7. Exhibitors of purebred animals must present a pedigree to the department superintendent upon arrival at the grounds and the paper must be furnished to the judge if called for.
- 8. All animals unloaded at the grounds must be exhibited in the ring otherwise no premiums will be given in that division and will not be eligible to be sold through the fair sale ring. Each animal must be entered and shown in at least one class or be removed from the grounds immediately.
- 9. NO ONE WILL BE ALLOWED IN THE RING EXCEPT PERSONS AUTHORIZED BY THE FAIR OFFICIALS.
- 10. All livestock are to be delivered to the fairgrounds clean! Wash rack priority will be: Thursday Horse, Friday Beef & Bottle Calf, Saturday Swine, Goats & Sheep. Animals are not to be fed in the wash racks or surrounding area.
- 11. Exhibitors are expected to obey the officials promptly in producing their livestock when instructed to do so. Any person refusing shall be ruled out of competition. Division superintendents WILL NOT go looking for exhibitors who are not in the ring when the class is ready to begin.

- 12. Any person knowingly misrepresenting age, breeding, etc. of stock or any person who shall attempt to interfere with the judge while in discharge of his or her duty or who shall on the premises of the Poweshiek County Fair Association use any disrespectful language in respect to the decisions or awards shall thereby be excluded from the fair for one or more years thereafter.
- 13. Any artificial means of removing or remedying physical defects or conformation in animals exhibited such as lifting or filling under the skin or filling of animals with a force pump will be considered as fraud and deception. All animals giving evidence of such treatment will be barred from exhibition at this fair and will be reported to the Iowa State Fair. Fair officials must be permitted to examine animal(s) upon request.
- 14. Livestock exhibitors will be required to supply feed and bedding. Only one bale of bedding on the aisle for each pen. Stalls and pens must be cleaned and manure hauled away each day. Animals are not to be fed in barn aisles. They are to be fed only in their stall or pen. Exhibitors are required to clean out their stalls, pens, cages, under cages etc. at the conclusion of the fair. ATTENTION HORSE EXHIBITORS A HORSE SUPERINTENDENT MUST CHECK OUT HORSE DEPARTMENT EXHIBITORS BEFORE LEAVING THE FAIRGROUNDS AT THE END OF THE FAIR. Those not complying forfeit their premium(s) in that division. Manure shall be deposited at west ends of barns only. Woodchips/shavings are to be used. No Straw. Woodchips/shavings will be available for purchase at the fair.
- 15. No extra stalls will be supplied to any club or person for any reason until all exhibits are in place. Exhibitors will receive stall/pen space needed for animals brought to the fair. Extra stall/pen space will be divided among clubs, not individuals. All grooming chutes will be left out of the barns unless room permits. Stall cards will be posted by division superintendents and ARE NOT to be moved without superintendent's permission.
- 16. Show ring and project sale dress code: See pages 19 & 20.
- 17. **Livestock sale:** Each exhibitor is allowed two (2) sales per division. All animals selling in the project/livestock auction can be signed up on one (1) card per

exhibitor. Project sale livestock sign up cards will be available at the livestock office located in the NW corner of the covered show ring. Complete your card and return it to the livestock office. There will be a sample card posted by the livestock office to use as a guide. The card is for livestock only. If you have questions about the new card please contact the fair office or a department superintendent.

The final deadline for reporting is Saturday at 8:00 p.m. (sheep immediately following show). If exhibitors miss the deadline they <u>WILL NOT</u> be allowed to sell the livestock that was not reported on time.

Livestock must be sold by the owner unless excused by the division superintendent & 1 fairboard director. If excused, another member from the county will be permitted to take the project/livestock into the sale ring. **Dress code is to be followed for the livestock sale. Back card numbers are not required.** 

- 18. Animals must be delivered in the same condition as when sold.
- 19. Any project offered for sale in an auction is considered to have changed ownership even if bought back by the original owner or if the owner refuses a bid or says, 'no sale'. All projects/animals offered for sale are terminated as 4-H/FFA projects. That means they are no longer eligible to compete at the Iowa State Fair. This ruling comes from the state 4H and FFA rules.
- 20. Steers having the permanent central incisor teeth up in wear are not eligible. Such animals are considered as having reached an age beyond that which is consistent with the intent and purpose of this show.
- 21. All fans used for cooling must meet safety standards. Superintendents' discretion will prevail. **No butt fans allowed on the fairgrounds.**
- 22. YQCA training is required for beef, dairy, meat goat, poultry, rabbit, sheep and swine exhibitors at the Poweshiek County Fair. Contact the Poweshiek Co. Extension Office for YQCA information. FFA exhibitors contact your advisor. Completion date of July 1<sup>st</sup>.

- 23. Any animal shown or entered in any other county 4-H or FFA Fair **CANNOT** be entered or shown at the Poweshiek County Fair as a 4-H or FFA project. ALL VIOLATERS WILL BE DISOUALIFIED.
- 24. To ensure animal safety, all feed and hay must be covered to prevent access by animals that the feed/hay is not intended for.

# **Protest, Discipline or Complaint Policy**

Any and all shall have 24 hours from the conclusion of the show involving the class in question, to file any protest, challenges of disciplinary action or complaints brought under the provisions of this premium book. The fairboard will not consider any protests, challenge of disciplinary action or complaints based upon the statement that a judge or judges are incompetent. Any and all protest, challenges of disciplinary actions or complaints shall be filed in writing and accompanied with a \$50.00 cash deposit of which will be forfeited if the protest is not sustained. Deposit must be filed with the fairboard president contemporaneously with any and all protests, challenges of disciplinary actions or complaints. Any and all may appeal any decisions of the fairboard concerning any protests, challenges of disciplinary action or complaints brought forth. Any and all shall have 24 hours from the entrance of a decision to appeal and shall be accompanied by a non-refundable \$100.00 cash deposit.

#### **HERDSMANSHIP**

The following guidelines will be used for judging each club's herdsmanship skills:

# 1. Cleanliness of Alleys and Pens – 60 points

- a. Bedding adequate, bright, dry, clean and in place.
- b. Animals securely tied and/or penned.
- c. Manure hauled out and deposited in proper place.
- d. Alleys swept clean, free of dust and woodchips.

# 2. Arrangement of Exhibit – 10 points

- a. Show boxes out of alleys and in a straight line.
- b. Hay and woodchips neat and orderly.
- c. Feed boxes and miscellaneous gear stored out of sight, if possible.

## 3. Appearance of Animals – 30 points

Animals are clean and brushed.

Judging will be by separate animal divisions. There will be a club winner in each animal division. Herdsmanship is the responsibility of the exhibitor(s). Judging will take place Wednesday thru Sunday. Divisions will not be judged on show day. A \$10.00 award will be given to each club/chapter winner in each division. A single club/chapter may win in more than one division. No attendant will be required but is encouraged. Herdsmanship awards will be given at 5:45 p.m. on Sunday in the show ring. Please have a representative present.

#### LIVESTOCK JUDGING CONTEST

Contest will be held in the covered show ring on Sunday, July 21st at 9 a.m. All 4-H & FFA members are eligible to participate. Clover Kids are not eligible. Breeding divisions of beef, sheep, goats & swine will be judged. **T-shirts will be provided but you must pre-register to receive one**. There are 2 ways to pre-register. 1. Indicate at the bottom of your Livestock Class Entry form or 2. Submit a Livestock Judging Contest entry form. Both forms can be found at poweshiekcountyfair.org and will be available when using the online entry option. Include what size of shirt is needed. Forms or online entry option must be submitted to the fair office no later than June 15<sup>th</sup> to receive a t-shirt. Pre-entry is not required for those not wanting a T-shirt. Questions please call the fair office at 641 236-7959.

#### SHOWMANSHIP

Junior, Senior and Winners

- 1. Junior Showman under 14 years of age as of the day of the show.
- 2. Senior Showman -14 years of age & over as of the day of the show or previous Junior winner.
- 3. Winners Showman A Junior winner may advance to Senior level regardless of age the following year. Once an exhibitor wins senior showmanship they may participate in Winners showmanship the following year. Once an exhibitor is eligible for winners showmanship they may participate in

- winners every year for the remainder of their years exhibiting at the Poweshiek County Fair. An exhibitor may win winners showmanship unlimited times.
- 4. Each exhibitor is required to show their own animal.
- 5. Previous winners in showmanship are not eligible to participate in the same age division. Exhibitor can only win his/her age group once.
- 6. Exhibitors must enter & exhibit in at least one class to be eligible for showmanship. Class entered & exhibited in must be in the same division as showmanship entered.

An exhibitor may not participate in more than one showmanship class per year per species. Example: A junior winner cannot participate in senior showmanship the same year they win junior OR a senior winner cannot participate in winners showmanship the same year they win senior.

**Horse Division** – See #10 in the horse department rules for specific showmanship age/grade breaks. All other showmanship rules apply.

# **Supreme Showmanship Competition Rules**

The Supreme Showmanship Contest will be a competition for the best overall showman of five animal species – beef, sheep, goats, swine and horses. Contestants will show all species, including the species for which they qualified for. All 5 qualifiers will be announced following the sheep show on Saturday evening. For questions contact the fair office.

- Each class in a particular species will be judged according to guidelines and practices of acceptable showmanship for that species. Exception for attire, see details below.
- A contestant has the option to not show a species if they feel uncomfortable handling the animal. In that case, the exhibitor(s) will be given 5th place for that species.
- Tie breaker will be determined by the total number of individual placings within the Supreme Showman contest starting with 1<sup>st</sup> place, then 2nd place and then 3rd and so on if there is still a tie.

- Judge(s) will be judging solely on the individual's showmanship ability and not on the presentation of the animal
- Judges will be limited to approximately 15 minutes per species class to judge and place the participants
- Judges' decisions shall be final
- Scores will not be made public
- Attire should consist of a neat appearance with an FFA or 4-H shirt, exhibitor number and boots. A cowboy hat is not required for showing horses.

Animals will be chosen by the species Superintendents. The exhibitor of each species will NOT be permitted to show their own animal in the species they represent. Exhibitors will be notified which animal they will be showing right before the class begins to ensure fairness for each contestant (that way there is no "practice time" before entering the show ring). The owner of the animal cannot talk to the exhibitors when handing off the animals.

- Consent from the owner shall be obtained before any livestock is used in the contest
- Superintendents are responsible for making arrangements with the owners to have the animals at ring side with the necessary show equipment (halter, lead line, show stick, whip...)
- Animals will be clean and presentable
- No animals will be clipped or fitted specifically for this class
- Judge(s) will take not the fitting of the animal into consideration since exhibitors will not know which animal they will be showing until just before they are ready to enter the ring

To qualify, win one of the showmanship classes (junior, senior, intermediate or winners) for a species. The judge will then rank the winners and the top eligible exhibitor will represent each species in the Supreme Showmanship Competition. Qualification will be done by the judge after the completion of all showmanship classes. There will be an additional qualifying class. Junior, Intermediate, Senior and Winners showmanship winners will return to the ring/arena to compete for Supreme Showmanship qualifier. Qualifiers will not be announced until after the conclusion of the sheep show on Saturday evening.

- If the top eligible exhibitor declines or is ineligible to participate, the next highest placing exhibitor for that species shall represent the species.
- What could make an exhibitor ineligible?
  - Exhibitors can only represent one species. If selected for more than one species, they will decide which species to represent. The next highest exhibitor (for the species not chosen) is then eligible to compete.
  - Supreme Showman winners from prior years are ineligible to participate for the same species they qualified for when they won. They can qualify, show, and win with a different species.
  - For example, if an exhibitor won Supreme Showman and the qualifying species was swine then all future years competing, the exhibitor may not qualify for the Supreme Showman Competition again with swine. The exhibitor <u>is</u> eligible to qualify for the competition with another species. Keep in mind that if the exhibitor qualified in a prior year for swine and did not win, then they may qualify in future years with swine.

Exhibitors will need to turn in 3 copies of their completed bottle calf worksheets prior to this date. (Please watch the newsletter for deadlines or contact chapter advisor). These worksheets will need to be brought to the Extension Office in Montezuma. FFA may submit them to the fair office. The exhibitors will be scheduled for a specific time to complete their conference judging.

- 6. All dogs must be on leash or crated while waiting for their class to be called.
- 7. This is not an AKC sanctioned dog show. However, AKC rules have been used as a guide.
- 8. Pinch collars are not allowed during the show.
- 9. Exhibitors participating in obedience, handling and rally classes need to check in at the livestock office the day of the show before the start of the first obedience class to pick up your exhibitor number and verify your class entries. The livestock office opens at 7:15 am.
- 10. Dogs are allowed only in the campgrounds during fair week unless they are being shown or they are a service animal. Dogs are not to be in or around buildings, show ring,

- arena, parking lot etc. This policy is for the safety of the public, exhibitors & livestock.
- 11. **Dress Code:** See Poweshiek County Fair General Information section.
- 12. No practicing will be allowed in the show ring on the day of the show.
- 13. No food or bait is allowed in the obedience rings.
- 14. Exhibitor and dog experience determine class level.

# **Dog Obedience**

#### Class

101 Intro Class: This class is for first year exhibitor with first year dog only. Dogs must not have earned any obedience title through AKC, UKC etc. Dogs must be able to do the following exercises: heel, figure 8 sit for exam, all on leash; recall on leash (no finish). Long sit (1 minute) and long down (1 minute) on leash.

# **Beginner Novice**

- **Beginners Novice A:** This class is only for dog and handler teams in their 2<sup>nd</sup> year of training. Dogs must not have earned any obedience title through AKC, UKC etc. Dogs must be able to do the following exercises: heel, figure 8, sit for exam, all on leash. Sit/stay (drop leash beside dog) handler walks ring. Recall off leash (no finish).
- 103 Beginners Novice B: This class is for dog/handler teams where either the dog has had previous training but this is the first year for the exhibitor or for an exhibitor with experience but this the first year for the dog. This class is also open to exhibitor/dog teams in their 3<sup>rd</sup> year of training that did not receive a qualifying score in Beginners Novice A last year. Any dog that has earned a "PCD" level title or higher before January 1 of current year is not eligible to enter these classes.

Dogs must be able to do the following exercises: heel, figure 8, sit for exam, all on leash; sit/stay (drop leash beside dog) handler walks ring, recall off leash (no finish).

#### **Preferred Novice**

- **Preferred Novice A:** A handler/dog team may enter this class 1 year.
- 105 Preferred Novice B: A handler/dog team may enter this class until they receive a qualifying score.

  Any dog that has earned a "PCD" level title or higher before January 1 of the current year is not eligible to enter these classes. Dogs must be able to do the following Exercises: heel and figure 8 on leash, stand for exam off leash, heel free off leash, recall with finish off leash, stay-sit or down, handler walks ring, sit stay-get your leash.

#### Novice A & B

- **106** Novice A: A handler/dog team may enter this class 1 year.
- 107 Novice B: A handler/dog team may enter this class until they receive a qualifying score. Any dog that has earned any "CD" level title before January 1 of the current year is not eligible to enter these classes. Dogs must be able to do the following exercises: heel and figure 8 on leash, stand for examination off leash, heel free off leash, recall with finish off leash, sit stay get your leash, group exercise sit & down stay.

#### Graduate Novice A & B

- **108 Graduate Novice A** For dogs attempting the dumbbell work and have not received a qualifying score.
- **109 Graduate Novice B -** For dogs that readily carry the dumbbell or have received a qualifying score in Graduate Novice A.

Dogs must not have received any "CDX" level titles. Dogs must be able to do the following exercises: heel free off leash and figure 8, drop on recall, dumbbell recall,

- dumbbell recall over high jump, recall over broad jump, stand stay get your leash.
- 110 Open Class: dogs must be able to do the following exercises: heel free and figure 8, command discrimination (stand, down, sit), drop on recall, retrieve on flat, retrieve over high jump, broad jump, stand stay-get your leash.

# **Rally Class**

- 1. The exhibitor is limited to 1 entry (dog) per class except Rally advanced where 2 entries are allowed.
- 2. Dogs must enter and leave the ring on leash. An exhibitor leaving the ring without the dog on a leash will have major points deducted from their score.
- 3. A dog who has received any Rally Novice title in any sanctioned show such as AKC (American Kennel Club) or UKC (United Kennel Club), etc, must compete in Rally intermediate.
- 4. AKC guidelines and rally signs will be used as judging guidelines for these rally classes. County fair courses will not be released until the day of the show. Exhibitors are to know the signs in their appropriate class level prior to entering the class.
- 5. Exhibitors will walk the course without their dog prior to showing. The judge will be available at walk through to answer any questions.
- 111 Rally Novice A For dogs which have not previously competed in any rally class & are in their first year of rally training. All exercises are performed on leash. There will be between 10-15 stations (start and finish not included) with a minimum of three and a maximum of five stationary exercises. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Rally Novice level signs will be used for this class.
- **Rally Novice B** For dogs which have competed in any rally class & are in their 2<sup>nd</sup> or 3<sup>rd</sup> year of rally training. Exhibitor/dog

combinations are limited to 2 years in this class. All exercises are performed on leash. There will be between 10-15 stations (start and finish not included) with a minimum of three and a maximum of five stationary exercises. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Rally Novice level signs will be used for this class. Novice A course will be used.

113 Rally Intermediate – For dogs which have competed in any rally class and are in their 3<sup>rd</sup> year of Rally training or more, or for a dog who has earned any Rally Novice title (AKC, UKC etc.). Exhibitor/dog combinations are limited to 2 years in this class. All exercises are performed on leash. There will be between 12-17 stations (start and finish not included) with a minimum of three and a maximum of seven stationary exercises. Intermediate courses will have a minimum of three advanced level stations. There are no jumps in this class. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog.

Exhibitors may touch their dog <u>only</u> for a stand exercise. AKC Rally Intermediate signs will be used for this class.

114 Rally Advanced – For dogs which have competed in a Rally class with 4 or more years in Rally training or for a dog who has earned any Rally intermediate title (AKC, UKC etc.). There is no limit on the number of years an exhibitor/dog combination can compete in this class. All exercises are performed OFF leash. There will be between 12-17 stations (start & finish not included) with a minimum of 3 and a maximum of 7 stationary exercises. Courses will have a minimum of 3 advanced level stations plus one required jump. Exhibitors are allowed to pat their legs, clap their hands or talk to encourage the dog. Exhibitors may touch their dog only for a stand exercise. AKC Advanced level signs will be used for this class.

# **Dog Agility**

Check in the day of the show between 7:15 a.m. & 7:45 a.m. Show will be held in the grassy area north & west of Exhibit Building.

The purpose of the youth dog program is to promote sportsmanship, demonstrate teamwork, develop and enhance a working relationship between dog/handler teams and to provide and promote an environment of positive, motivational and reinforcing training methods.

- 1. To enroll in agility, a dog-handler team must have completed an obedience class.
  - Dog-handler teams that have earned an agility title in any AKC, USDAA, NADAC venue may enroll in advanced agility.
- 2. Dog-handler teams wishing to participate in agility must also participate & compete in one obedience or rally class.
- 3. Each dog-handler team must start at the Novice level of agility.
- 4. Agility is a course consisting of various obstacles with 3 levels of competition, each increasing in difficulty. Each dog/handler team must begin at the first level prior to progressing.
- 5. For the safety of the dogs they must be a minimum of 12

- months old for agility competition. Younger dogs may attend agility training classes but will not be allowed to compete until 12 months old.
- 6. No dog with any physical or mental condition that would impair performance will be allowed to compete in agility. Some examples include hip dysplasia, obesity, slipped stifles or advancing age. A judge and/or county instructor will have the authority to stop participation of any dog whose soundness they question. Exhibitors are strongly encouraged to contact their veterinarian if they question their dog's ability to participate.
- 7. Dogs who exhibit aggression toward other dogs or people will not be tolerated and will not be allowed to participate in the dog project.
- 8. Training aids and treats are not permitted during competition. An exhibitor may reward their dog when they have left the competition ring gating.
- 9. Exhibitors may run dogs on leash.

Please note that these rules are to ensure that a working relationship has been established between the handler and dog.

In performance classes, including timed events, exhibitor's numbers are to be worn on both sides of the saddle pad. Violation of the dress code will result in forfeiture of all fair premiums.

No health papers required, animals will be inspected at the fairgrounds.

- 1. IDENTIFICATION REQUIREMENTS ONLINE VERIFICATION FOR SHEEP BROUGHT TO THE IDENTIFICATION DAY at v2.4honline.com by May 15. ID day is the 1<sup>st</sup> Saturday in May at the fairgrounds. All others need to be entered and verified at v2.4honline.com by May 15. FFA need to attend ID day.
- 2. Entries in market classes and commercial ewe must have lambed after January 1 of current year and owned by members. (see animal science rule #2 for exceptions).
- 3. Market and commercial lambs must be weighed and tagged at scheduled weigh-ins at the fairgrounds. All ewe lambs & yearling ewes must have birth date on ID form on v2.4honline.com. FFA need to record on their ID forms.
- 4. Members may enter and show one pen of three (3) market lambs and four (4) individual market lambs. FOUR (4) market lambs plus TWO (2) commercial ewes and TWO (2) commercial yearling ewes may be brought. Pen of 3 MUST come from the four (4) individual MARKET lambs.
- 5. Lambs will be sold by the weight at weigh in.
- 6. Lambs may be put into a speckled or white face class at the time of weigh-in.
  - Speckled face lambs must have white on any two (2) of the following three (3) areas (face, ears or legs). Please be prepared to identify these lambs for those classes. No pre-entry necessary.
- 7. All lambs should arrive at the fairgrounds clean and show ready. (Suggested Market/Commercial wool length –slick sheared)
- 8. **Drenching will NOT be allowed.** Some of the products being used are not labeled for animal use. There are quality assurance issues involved with this practice.
- 9. Exhibitors will be given a check in card at the fair check/weigh in to put their sheep into classes. Complete this card and return it to the sheep superintendents no later than 9 pm Tuesday July 16th.

# **BOTTLE LAMB**

Bottle lambs are not required to be brought to the county tag/weigh, ID day. Information required on ID form is face color, sex, date of birth & flock tag # (if lamb has a tag). Ear tags are not required but are recommended. Send completed ID form to the Extension Office or submit to FFA Advisor. No health certificate required. Animals will be inspected at fairgrounds. Scrapie tags required.

- 2. Two (2) lambs per exhibitor may be brought to the Fair.

#### ATTENTION SWINE EXHIBITIORS – CHECK IN PROCEDURE

Due to regulations by the Iowa Department of Agriculture and Land Stewardship and the State of Iowa Veterinarian the following procedure will be required for exhibiting swine at the 2024 Poweshiek County Fair: Swine will be checked on the trailer or truck by the official fair veterinarian before being unloaded at the fairgrounds on Wednesday, July 17<sup>th</sup> from 6 – 8 a.m.

All swine must go through this check in procedure or they will not be eligible to be shown.

No pigs are to be unloaded until they have been checked by the fair veterinarian. After inspection pigs may be unloaded and stalled in the barn.

If you have any questions please contact swine superintendent Ryan Iverson at 641 325-1174 or the Poweshiek County Fair Office. **WEIGH IN SCHEDULE**: Wednesday July 17th 6-9 a.m. **Exhibitor** or a family member must be present when their swine is weighed.

- 1. All market pigs will be ear tagged with a county, FFA or 840 ear tag and EAR NOTCHED by the National Ear Notching System.
- 2. Swine must either be identified and verified at v2.4honline.com. or FFA exhibitors will submit their ID forms to the fair office at the fairgrounds by May 15. All purebreds must be farrowed after January 1st. Only pigs that match the original identification will be allowed to show at the Poweshiek County Fair. IF A PIG LOOSES A TAG BEFORE THE FAIR IT MUST BE REPLACED. NO PIGS WILL BE ALLOWED THAT DO NOT HAVE A 4-H, FFA OR 840 EAR TAG IN THEIR EAR WHEN THEY ARRIVE AT THE FAIR. THIS NEW EAR TAG MUST BE RECORDED ON THE ID FORM. TO HAVE TAGS REPLACED CONTACT EITHER THE EXTENSION OFFICE, FFA ADVISOR OR SWINE SUPERINTENDENT. Please notify the fair office of any tag replacements.
- 3. ALL EXHIBITORS MUST BE YQCA CERTIFIED. CONTACT THE EXTENSION OFFICE OR FFA ADVISOR FOR DETAILS.

# 4. HEALTH REQUIREMENTS - No health papers required.

No testing for pseudorabies required. However, each exhibitor must sign and turn in an owner affidavit that states animals being exhibited did not originate from a quarantined herd and to the best of their knowledge, swine dysentery has not been in evidence in their herd for the past 12 months. Affidavits are available from the swine superintendents and are to be turned in with weigh-in cards.

- 5. Each exhibitor may enter and show a maximum of 10 pigs. The following are the maximum swine entries each exhibitor can show at the fair:
  - i. 6 market hogs (purebred & crossbred but no more than 4 of one type)
  - ii. 4 breeding gilts (purebred & crossbred but not more than 2 of one type)
  - iii. 1 pen of 3 comprised of any market swine the exhibitor brought to the fair
  - iv. Market hogs will be shown in the following divisions:
    - 1. Crossbred market barrows
    - 2. Crossbred market gilts
    - 3. Purebred market barrows
    - 4. Purebred market gilts
      - a. Depending on the number of purebred animals shown, gilts & barrows may be combined into one class of multiple breeds. To qualify for a breed class-3 purebred market animals must be exhibited.
    - v. Breeding gilts will be shown in the following divisions:
      - 1. Crossbred breeding gilts
      - 2. Purebred breeding gilts
        - a. Depending on the number of purebred animals shown, breeds may be combined. To qualify for a breed class, 3 purebred breeding gilts must be exhibited.
    - vi. Gilts can only be shown as a market pig or breeding gilt, not both.
    - vii. All purebred animals must have the original registration paper checked in when the animal is weighed. The registration paper must be in the exhibitor's name or in partnership. All purebred breeding gilts must follow

breed association guidelines and requirements for exhibition.

- 7. Individual market pigs and pens of 3 in each weight class will be placed in blue, red or white award groups according to type, finish and market desirability, corresponding to market hog grades of US #1, #2, #3.
- 8. 1st and 2nd place market barrows and gilts, pens of 3 and breeding gilts will be selected in each weight class. In the individual market classes, only 1st and 2nd place pigs from classes weighing a minimum of 225# will be eligible to show for Champion and Reserve Champion. Pens of 3 and breeding gilts, 1st and 2nd place pigs are eligible for Champion and Reserve Champion. Champion and Reserve market barrows and gilts will compete for Grand Champion and Reserve Grand Champion Market Pig
- 9. Superintendents reserve the right to split classes at any weight and decide sale order of livestock.
- All swine will be weighed for classification on Wednesday, July 17th. Official fair scale weight will be used with no re-weighs. Pigs will be sold on this weight.
- 11. All swine are to be delivered to the swine barn clean.
- 12. All swine exhibitors must complete the Project Sale
  Livestock Sign Up Card & return it to the livestock office by
  8 p.m. Saturday if they wish to sell hogs in the sale or send
  them to market via the designated buyer. Any exhibitor
  sending pigs to a commercial packer either directly or
  through the fair sale will be required to sign an affidavit
  provided by the packer stating their pigs have never been fed
  Paylean.
  - i. Each exhibitor may keep 2 pigs to go through the fair sale ring.
  - ii. Each exhibitor can sell any pigs to the designated buyer permitting each animal weighs more than 225 lbs.
  - iii. Each exhibitor can take any of their swine back home, but they must stay at the fair until release time.
- 13. Due to limitations of the packers, the fairboard will not provide a market for any swine weighing less than 225 lbs. and will not be allowed to go through the sale.

- 5. Exhibitors need to be prepared to answer the interview questions (noted in #10) with a judge the day of the show.
- 6. Bucket/Bottle animals must be born in year of the show.
- 7. All Clover Kid animals must follow all health requirements and check in procedures required for exhibitors. Exhibitors are required to furnish their own bedding. Woodchips/shavings only, no straw. Bottle calves only will be provided bulk bedding at \$10 per calf. Bedding fee will need to be paid at time of entry. No refunds. Bucket/bottle animals must be

# brought in by Tuesday, July 16<sup>th</sup> from 5:00 to 8:00 p.m. Check in with Extension staff.

- 8. Bottle calves are to be shown with a halter and lambs/kids should be shown with a halter.
- 9. Each Exhibitor will be responsible for identifying his/her own rabbit if they should get loose at the fair.
- 10. During conference judging, the exhibitor will be use showmanship skills and be asked the following:
  - 1. Showmanship:
    - The animal needs to be clean and neat.
    - b. The exhibitor can handle the animal with some assistance from the adult if needed (Looking for a relationship between exhibitor and project).
    - Keep the animal between themselves and the judge.

#### 2. Interview:

- a. Where did you keep your animal?
- b. What did you feed your animal?
- c. What was your favorite part of raising your animal?
- d. What was least favorite part of raising your animal?
- 11. Participation ribbons will be given for this class. No premiums will be paid.
- 12. Exhibitors are to wear a Clover Kid or Club t-shirt in the show ring and will be given a back card for showing.
- 13. Animals are released at 3:00 p.m. on Sunday, July 21st.
- 14. Stall cards will be put up by the superintendents.
- 15. Bottle calves shown at the Poweshiek County Fair in 2024 by a 3<sup>rd</sup> grade Clover Kid exhibitor are eligible to be brought back as a 2<sup>nd</sup> year bottle calf their 1<sup>st</sup> year of 4-H.

ANY EVIDENCE OF WARTS, RINGWORM, FOOT ROT, PINK EYE, DRAINING ABSCESSES OR ANY OTHER CONTAGIOUS OR INFECTIOUS CONDITION WILL ELIMINATE THE ANIMAL FROM THE SHOW. See health requirements for exhibition of livestock.

#### SHEEP AND GOATS

All sexually intact sheep must have an individual Scrapie Flock of Origin identification tag. All sexually intact goats must be identified with an

individual Scrapie Flock of Origin identification tag or by an official tattoo registered with USDA (to register, call 1-866-USDA-TAG; 1-866-873-2824).
